Subject: Third Warning – Low-Altitude Flyovers Above Residential Property

This past weekend and again today, the following aircraft flew directly over my house at low altitudes and with excessive noise:

-Sunrise Aviation Inc – N41538 (Piper PA-34-200 Seneca, twin-engine piston) <-----Which who owns the plane was hidden from radar----->Why?

-Van Anda Aviation LLC – N596CS (1997 Cessna 172R Skyhawk)<-----no reason to fly over my house----->

-TFA Aircraft Holding Corp – N4653L<-----no reason to fly over my house----->

-Phoenix East Aviation – BPX257, BPX209, and BPX290----->Convinced this company IS run by very bad managers. If I were the owner flight instructors and managers would be fired.----->

This is the third time I've raised this concern. Your flight paths need to be adjusted immediately to avoid flying over residential areas like mine. These repeated disruptions are unacceptable and being documented. Please consider this a final warning before further action is taken.

IMPORTANT NOTE: Just a quick notice — I'll be learning to fly a drone over the next couple of weeks in my backyard and the nearby open field. The drone will be flying frequently and will operate at altitudes between 100 to 500 feet directly above my property.

Please be aware and watch out for it when outdoors or flying anything nearby. I appreciate your understanding as I practice. It is my right to do so. Also on 4th of July avoid flying over my house I will have fireworks that will exceed 500ft. You need to be aware of this also. Thanks!

1. Use FlightRadar24 to track flight paths over your home. Take screenshots. Create image to send to them. The paths in this tool is off by half a block, the plane might go over your house but in the App it will show it half a block away. It's because of many issues with GPS and the boxes on the planes, trust your visuals.
2. Take screenshots or videos of planes flying low through your neighborhood.
3. Email the flight schools Attach them to the emails and demand they stop routing through residential areas.
