# Release, Indemnification, Hold Harmless & POIPA Agreement in favour of Champs Boxing Academy

### **Definitions**

Champs Boxing Academy and their members, officers, directors, agents, employees, heirs, assigns and independent contractors hereafter referred to as CBA.

Training Classes, private training hereafter referred to as Training

#### Personal Disclaimer

I provide information concerning, but not limited to, physical fitness. I am not a medical health practitioner or mental health provider and I do not hold myself out to be in any capacity. Rather, I serve as a coach, mentor and guide who helps you reach your own health and wellness goals.

#### **Medical discla**imer

**CBA** recommends that you consult with your physician before commencing any exercise program. You should be in good physical condition and be able to participate in the exercise. **CBA** is not a licensed medical care provider and has no expertise in diagnosing, examining or treating medical conditions of any kind, or in determining the effect of any specific exercise on a medical condition. You acknowledge that you take full responsibility for your health, life and wellbeing, as well as that of your family and children (born and unborn, as applicable) and all decisions now or in the future.

## 1) Release, Indemnification and Hold Harmless Agreement

I understand that there are risks and dangers in participating (including waiting at, or on, any premises to participate in such training, walking through premises prior to or after such classes) and that in order to participate, in any such activities, including but not limited to: Boxercise, Boxing, Krav Maga and any other training. I give up my rights to hold **CBA** responsible or liable for any damage that I may suffer participating in such training provided by them.

I hereby voluntarily and forever release, discharge and hold completely harmless CBA from any and all responsibility for, or liability resulting from or arising from, my participation in training with or at CBA.

I understand that training provided at **CBA** may include, but will not be limited to, activities such as boxing, punching, hitting, stretching, jabbing, lunging, rolling, falling, twisting, jumping, running, yelling. I realise that these activities can be dangerous, but I am voluntarily choosing to participate in some or all these activities and agree to assume the risk associated with my participation therein.

I understand that I am assuming full responsibility for any and all risks of death, personal injury, emotional pain and suffering, property damage and economic loss that might be suffered by me as a result of my participation in training at **CBA**. I agree that this release shall bind me, my spouse, my heirs and their agents and my employer/employees.

By signing this release, I have expressly assumed all the risks associated with participation in such activities, including but not limited to the negligence on part of the **CBA** instructors in the performance of their duties, negligence by other members of **CBA**, negligence in the operation of machinery or equipment, and / or premises liability.

I have read this agreement and understand the contents and language herein and I am advised of all potential dangers incidental to participation in Boxercise training including travelling to and from. I understand the rights that I am giving up by signing below where indicated.
