Dear Nob Hill Neighbors,

26 ballots will be distributed, with each property on Nob Hill Road and Hunter Hill Road receiving one valid ballot. Each ballot issue will be decided based on 51% or more of the total number of votes cast for that issue or choice. That is, if only 10 votes are cast for a particular issue, the issue or choice would require 6 to pass.

VOTING RULES:

- Only one vote per property will count. If two or more votes are received from a property, one ballot will be voluntarily withdrawn at the property owners' discretion or, if owners are unable to agree, one will be randomly selected by the Board as valid.
- According to District Bylaws, owners of multiple properties will be able to cast a vote for each of their properties.
- You may submit a completed ballot, one per property, in ONE of three ways:
 - PAPER, mail or hand, in-person to any of the officers of the district or call and we
 will pick it up by the deadline
 - EMAIL PDF to info@nhrsrd.org.
 - ONLINE those receiving email will receive a ballot for online voting. No paper needed.
- The deadline to submit a ballot is August 22, 2025. Without prior arrangements, ballots received after that date will not be counted. There can be no flexibility in this rule.

Issue 1. Budget for FY 2025.
