

# Entertainment Contract Between Maddawgs Entertainment and Client

This agreement between the above-named Client(s), hereinafter referred to as "Client," and **Maddawgs Entertainment** is to be bound by the following terms:

---

## 1. Services Provided by Maddawgs Entertainment

Maddawgs Entertainment shall provide entertainment services specifically identified above, which may include sound equipment, lighting, music, and other equipment as listed; a professional disc jockey entertainer; continuous music for the time specified above; and delivery, setup, and breakdown of all equipment for the event.

---

## 2. Client Responsibilities

Client shall provide one six-foot or eight-foot banquet table for Maddawgs Entertainment's use, located near a functional 110V AC outlet. Maddawgs Entertainment requires protection from the elements, such as rain or wind, as well as placement out of direct sunlight and/or overhead protection from the sun.

Client shall secure the use of any site or facilities (event location), including any payments, fees, stamps, licenses, authorizations, or permits needed for Maddawgs Entertainment to perform as agreed.

This includes adequate time for Maddawgs Entertainment to set up (1 hour prior to guests' arrival) and take down equipment (30 minutes).

---

## 3. Payment Terms

Client agrees to the following payment terms:

- A \$200 deposit for a contract valued over \$500,
- OR a \$100 deposit for a contract valued under \$500.

A signed copy of this contract (digital or hard copy) is required to reserve the date.

The remaining balance is due **7 days before the event date**, including any options or extra time, which is billed in half-hour increments. Any unused prepaid extra time will be refunded within 7 days after the event.

Maddawgs Entertainment is not responsible for events that end early, including due to circumstances beyond our control such as weather, power outages, or venue restrictions.

---

#### **4. Cancellation / Release From Contract**

A Client may request release from this contract in writing, including the reason for the request and the Client's signature. Maddawgs Entertainment reserves the right to approve or deny this request at its discretion.

If the request is made at least **90 days prior** to the scheduled performance date, Maddawgs Entertainment will refund the deposit amount minus a \$40 processing fee.

---

#### **5. Changes / Rescheduling**

If the Client wishes to reschedule the event, Maddawgs Entertainment will hold the payment and apply it without service charges, provided the new date is available. Events are reserved on a **first-come, first-served** basis.

Prices and discounts for new dates may differ. A newly signed contract must be submitted to confirm the updated reservation.

---

#### **6. Liability**

This contract represents the sole agreement between Maddawgs Entertainment and the Client and supersedes all other agreements or representations, including verbal agreements.

Maddawgs Entertainment's liability for this event is limited strictly to the value of this contract or the total amount paid by the Client to Maddawgs Entertainment, whichever is less.
