Bounce House Rental Agreement & Liability Waiver

1. Acknowledgment of Risks

I, the undersigned, acknowledge that the use of an inflatable bounce house involves inherent risks, including but not limited to, physical injury, falls, collisions, or other accidents that may result in serious injury or death. I understand and accept full responsibility for the risks associated with the use of the bounce house and any associated equipment.

2. Assumption of Liability

I agree to assume full responsibility for the supervision of all participants using the bounce house during the rental period. I understand that Maddawgs Entertainment LLC does not supervise the use of the bounce house and is not responsible for any injuries or damages resulting from its use.

3. Release of Liability

I, on behalf of myself, my children, guests, invitees, employees, and agents, hereby release, waive, and discharge Maddawgs Entertainment LLC, its owners, members, employees, and agents from any and all claims, liabilities, damages, or causes of action arising out of or related to the rental, use, or operation of the bounce house, whether caused by negligence or otherwise.

4. Indemnification

I agree to indemnify and hold harmless Maddawgs Entertainment LLC, its members, agents, and employees from and against any claims, demands, losses, damages, liabilities, and expenses (including attorneys' fees) arising from or related to the use of the bounce house during my rental period.

5. Safety Rules & Supervision

I acknowledge receipt of and agree to follow all safety instructions provided by Maddawgs Entertainment LLC. I understand that adult supervision is required at all times during use. I agree not to allow horseplay, flips, or roughhousing inside or around the bounce house.

NOTE: Age and weight limits vary by bounce house model. Limits are clearly posted on each unit and must be followed at all times.

6. Equipment Condition

I agree to return the bounce house and all related equipment in the same condition as received. I will be responsible for any damage beyond normal wear and tear, including but not limited to punctures, tears, and staining.

7. Weather Policy

I understand that the bounce house must not be used during rain, high winds, or other hazardous weather conditions. If such conditions arise, I agree to deflate and secure the bounce house immediately.

8. Cancellation & Refund Policy

Cancellations made more than 48 hours in advance will receive a full refund. Cancellations within 48 hours may be subject to a cancellation fee. Weather-related cancellations will be handled on a case-by-case basis at the sole discretion of Maddawgs Entertainment LLC.

9. Electronic Signature & Consent

By signing below, I acknowledge and agree that my electronic signature is legally binding and carries the same validity as a handwritten signature. This agreement may be signed electronically and retained in digital
