Tournament Rules:

1. Entrants must be USBC sanctioned and a member of Mid-Hudson Valley Women's 600 Club.
2. Entrants will bowl three(3) games on one(1) pair.
3. The tournament will be 80% handicapped based on 220 scratch.
4. Average requirements are as follows:
 - a. Entrants will use their highest USBC certified league average as a regular or substitute bowler, for the 2024-2025 winter season (minimum 21 games)
 - b. Bowlers who do not have a a previous winter season average will use their highest average as of the reserve closing date of the entry, minimum 12 games; average verification must be presented at the tournament. All others will bowl scratch. USBC Rule 319A-1 will apply (regarding summer averages).
 - c. USBC Rule 319A-2 regarding current season average being 10 pins higher than previous season WILL NOT apply.
 - d. All averages will be verified and scores will be adjusted to match certified average if a discrepancy with the submitted average is found.
 - e. Reporting of previous tournament winnings SHALL NOT apply (USBC Rule 319D)
 - f. Average adjustment requirement SHALL NOT apply (USBC 319E)
5. There is no refund of entry fee. Entries received after the closing date will be subjected to an additional \$5.00 processing fee. (RESERVE ENTRIES close January 18, 2026)
6. Entrants who wish to bowl together on the same lanes, should submit their entries together.
7. In the event of a tie for first place, a one(1) game roll off will take place immediately following.
8. Handicap prizes will only be awarded
