Minutes from the previous meeting were accepted as printed in the August newsletter.

Treasurer's Report – We have 1864.24 in the checking account.

Board report – None this month. However there was discussion on the urgency that we need to have one before the end of the year in order to stay in compliance with our corporation.

Old Business:

- Wayne presented an example of the Fly-In flyers to be used for next year. A few changes were discussed and an updated copy will be forthcoming.
- Safety nets were tabled for now and will be repaired next spring
- The idea of a fund raiser rummage sale was discussed, but tabled until the January-February timeframe
- Dave brought up the idea of an expansion to the storage shed, changing it from an 8'x8' to an 8'x16' with an 8'x16' pavilion (essentially a 16'x16' structure). At this point this will be tabled pending more information as well as additional funds.
