Refund Policy Overview — Coaching Services vs. Digital Products

Royal Court Solutions LLC offers both coaching services and digital products. Refunds are handled differently depending on the type of purchase:

Digital Products

All digital product sales are final. Because customers receive immediate access to course materials, downloads, assessments, journals, or workbooks, we do not offer refunds for any digital products under any circumstance.

Coaching Services

Coaching sessions may be refunded only if the service has not been delivered. Once a coaching session, consultation, or appointment has been completed, no refunds will be issued. Clients may reschedule according to the cancellation policy, but coaching services are non-refundable after delivery.

This clarification applies to all Royal Court Solutions LLC offerings and supersedes any generalized product-return language in the policy below.

Definitions and key terms

To help explain things as clearly as possible in this Return & Refund Policy, every time any of these terms are referenced, are strictly defined as:

- **Company:** when this policy mentions “Company,” “we,” “us,” or “our,” it refers to Royal Court Solutions LLC, that is responsible for your information under this Return & Refund Policy.
- **Customer:** refers to the company, organization or person that signs up to use the Royal Court Solutions LLC Service to manage the relationships with your consumers or service users.
