Homosassa has a fish with your name on it, so let Artificial Only help you catch it! With Captain Don at the helm, you're in knowledgeable and experienced hands.

You're likely to fish for Redfish, Scallops, Snook, Spotted Seatrout, and more, depending on conditions. On these trips, it's common to drift using light tackle.

GAG GROUPER TRIPS – Captain Don will be running Gag Grouper trips from September 7th thru the 13th, 2025 on his 22 ft sail fish boat. Rates are \$275 for 4, and \$255 for 5 anglers. This is a full-day trip leaving at 6:30 am from Monkey Island running 30 to 50 miles offshore. Rods, bait, fish cleaning and bagging is included. Tip is extra.

Fishery Management updates

Gag Grouper season opens Sept. 1-14 in Gulf state waters

The 2025 recreational gag grouper season for Gulf state waters will be open Sept. 1-14. It will close at 12:01 a.m. on Sept. 15. Per the FWC website, the daily bag limit is "2 per person within the 4 Grouper aggregate" with a minimum size of 24 inches. Given the extremely short Gag season, dates will be difficult to obtain. Your Club is working to secure dates. Stay tuned for details.

Sharked Act introduced into the Senate

On Monday, Senators Rick Scott and Brian Schatz officially introduced the SHARKED Act (S. 2314), which would establish a task force to improve coordination, identify research priorities, and evaluate funding opportunities to address shark depredation.
