

Firearm Storage and Transfer Agreement On Target Storage And Transfer

a licensed FFL ("Storage Provider"), and the undersigned Customer. 1. PurposeCustomer transfers possession of firearm(s) listed in Exhibit A to Storage Provider for secure storage per federal, state, and local laws. Storage Provider agrees to store firearm(s) compliantly and facilitate return or transfer to Customer or another FFL per this Agreement. 2. Storage FeesCustomer pays \$_____ per firearm, due first day of each (circle one): month / year. First payment due upon signing; subsequent via cash, credit card, or digital payment. 3. Return or TransferFirearm(s) returned to Customer only after successful Virginia State Police background check (Va. Code § 18.2-308.2:2) confirming eligibility. Alternatively, Customer may transfer to another FFL at own expense (fees, shipping, paperwork). Storage Provider may deny return if Customer fails check or is prohibited by law. 4. Non-PaymentFirearm(s) not returned until all fees paid in full per this Agreement. 5. Hold HarmlessCustomer indemnifies and holds harmless Storage Provider, owners, employees, agents, and affiliates from claims, damages, losses, liabilities, costs, or expenses (including attorneys' fees) arising from: Customer's ownership/use/misuse of firearm(s); Customer's legal violations; third-party claims related to firearm(s); or Customer's breach. Survives termination. 6. Customer RepresentationsCustomer warrants: legal ownership or authority over firearm(s) in Exhibit A; firearm(s) not stolen, with no liens/encumbrances/disputes; Customer not prohibited from possessing firearms under federal/state law. 7. Storage ConditionsFirearm(s) stored securely in climate-controlled environment per ATF and Virginia law. Storage Provider not liable for damage from acts of God, disasters, or events beyond reasonable control. 8. InsuranceStorage Provider maintains business liability insurance. Customer responsible for additional firearm coverage if desired. No liability for loss/damage except as required by law. 9. TerminationCustomer may terminate by requesting return (post-check and paid fees) or transfer to another FFL (at expense). Storage Provider may terminate with 30 days' written notice for any reason, including non-payment or breach. In event Customer is deceased or incapacitated and unable to recover firearm(s), they designate the below successor/beneficiary to receive firearm(s) subject to legal requirements, background check, and fees. Storage Provider will require proof of eligibility and authority.
