

On Target Storage and Transfer Firearm Storage Agreement

This Agreement, dated _____ (MM/DD/YYYY), is between On Target Storage and Transfer, a licensed Federal Firearms Licensee ("FFL") at the above address ("Storage Provider"), and the undersigned Customer.1. Purpose: The Customer transfers the firearm(s) listed in Exhibit A to the Storage Provider for secure storage per federal, state, and local laws. The Storage Provider will store and return or transfer the firearm(s) per this Agreement.2. Fees: Customer pays \$_____ per firearm, due on signing and the first day of each (circle one): month/year. Late payments incur a \$_____ fee if unpaid within _____ days. Payments accepted: cash, credit card, digital payment.3. Return/Transfer: Firearm(s) return requires a Virginia State Police background check (\$2 fee) and ATF Form 4473 completion. Customer must be eligible to possess firearms. Alternatively, Customer may transfer firearm(s) to another FFL at their expense (fees, shipping, paperwork). Storage Provider may deny return if Customer fails the background check or is legally prohibited.4. Non-Payment/Forfeiture: If storage fees are unpaid for 12 consecutive months, firearm(s) are deemed abandoned. Storage Provider will notify Customer via [certified mail/email] 30 days prior. Abandoned firearm(s) may be sold, transferred, or destroyed per applicable laws.5. Hold Harmless: Customer indemnifies Storage Provider, its owners, employees, and affiliates from claims, damages, or liabilities arising from Customer's firearm ownership, use, misuse, legal violations, or third-party claims. This survives termination.6. Customer Representations: Customer confirms they legally own or control the firearm(s), which are not stolen, have no liens/disputes, and Customer is not prohibited from possessing firearms.7. Storage Conditions: Firearm(s) will be stored securely in a climate-controlled environment per ATF and Virginia laws. Storage Provider is not liable for damage from acts of God or events beyond its control.8. Insurance: Storage Provider maintains general liability insurance. Customer is responsible for additional firearm insurance if desired.9. Termination: Customer may terminate by requesting return (subject to background check and fees) or transfer to another FFL. Storage Provider may terminate with 30 days' notice for any reason, including non-payment.10. Governing Law: Governed by Virginia and federal law. Disputes resolved in Virginia Beach, VA courts.11. Entire Agreement: This Agreement and Exhibit A are the full agreement, superseding prior agreements. Amendments must be written and signed.
