A Time of Unprecedented Challenges (2020-2021)

Dear Friends, Partners, and Resilient Supporters,

The years 2020 and 2021 presented our community, and indeed the world, with unprecedented challenges in the form of the COVID-19 pandemic. This combined annual report for these two extraordinary years reflects not only the significant disruptions we faced at ACYP but also the remarkable adaptability, resilience, and unwavering commitment of our team and partners in safeguarding the children we serve during this turbulent period.

Lockdowns, school closures, and increased economic hardship created heightened vulnerabilities for children, often isolating them from protective networks and increasing their exposure to violence within the home and online. For the year 2020-2021, some child protection initiatives were put on hold until October 2021 due to Covid-19 pandemic and continued lock downs.

 Home Visits and Support: Providing targeted support and guidance to vulnerable families to strengthen their capacity to care for and protect their children.

8. Economic Empowerment Initiatives

 Implementing programs that aim to reduce poverty and financial stress within families, as economic hardship can be a contributing factor to violence and neglect. This could include vocational training, micro-loan schemes, or support for income-generating activities.

9. Collaboration and Networking:

- Strengthening Partnerships: Building and maintaining strong relationships with government agencies (police, probation, social welfare), other NGOs, faithbased organizations, traditional authorities, and community-based organizations working on child protection.
- Joint Awareness Campaigns and Activities: Collaborating with partners to amplify messages and reach a wider audience.
- Information Sharing and Referral Systems: Establishing clear referral pathways and protocols with partner organizations to ensure children receive appropriate support services.
- Advocacy: Engaging in advocacy efforts at local and potentially national levels to promote child protection policies and legislation.

Challenges faced in case management

22 in number constituted the cases reported and handled by ACYP. 3 were sexual, 13 were physical, 4 were emotional and 2 were neglect. All were handled through our case management process. The police, probation office, CDO's and health workers were instrumental in supporting the process from the start to the end. Legal support was thought and happily provided by a free legal service provider in Masaka. The support provided included, PSS, referral for medical, transportation of survivors. Some of the case were not reported or handled at family levels and these were difficult to track down.

Challenges and Lessons Learned

- o The limited interaction due to lock-down.
- Some professional who were out of work and did not have money reported that they could not make phone calls to report
- Staying home for many ours resulted into GBV which increase violence against children as well

Looking Ahead for 2022

- Prioritizing genuine community participation and ownership.
- o Strengthening inter-agency collaboration and coordination mechanisms.
- o Investing in comprehensive and ongoing training for all involved personnel.
- Focusing on primary prevention strategies alongside response mechanisms.
- Ensuring child participation in all stages of the program cycle.
- Fostering long-term partnerships and sustainable solutions.
