4. Traffic Calming in the village....A constant concern but one that is difficult and expensive to remedy. The nature of the twisting lanes is not conducive to speed check cameras. 'Pinchpoints' of concern are the Middle of Town. Penfold Lane and at the bottom of Butterton Moor Bank. A flashing light system/smiley/sad faces advising/encouraging traffic to slow down would cost in the region of thousands of pounds and does not guarantee their success. **Cllr Kempster will enquire as to legalities of siting of poles and signs.** The PC continues to monitor the situation.

* Caravan at rear of Patten House....Advice has been sought from PDNPA Planning.

* Gritting in the Parish....The Clerk has had a conversation with Dave Rushton but the outcome was not encouraging. SCC Reportonline MUST be used in the event of concerns. Cllr Kempster has looked at the gritting map and it is basically not fit for purpose.
