



## EXAMPLE ONLY - Safety & Security Post Event Report Farm Fest

### Crossley Farm, 120 Crossley Lane, Mirfield WF14 0NX

Farm Fest 2024 took place on the 7<sup>th</sup> Sept 2024 and was a complete success. It was attended by the local community and several officials and was met with nothing but compliments. There were no security or safety impacts of any significance. The owners and organisers met all the expected standards and criteria of the planning and management for such a public and crowded place event.

This post event report is design to be a practical review of the scope of the process of how the Event Organizers/landowners in liaison with local authorities; Kirklees MC and WYP and Watchguard International (WIL) who collaborated to ensure that the event was a success in safety and security.

Key focus points of the report will demonstrate that, in order to facilitate a safe and secure public event venue, whether it be:

- an external festival, community event, parade, etc.;
- an internal nighttime economy location such as clubs, pubs, restaurants, eateries, and similar;
- any other daytime crowded place environment, including those subject to the forthcoming Martyn's Law requirements, that;

There is a need to assess "in-place" arrangements at every level against all current laws and guidance for public space safety and ensure they are followed and adhered to. By not identifying or missing foreseeable threats, there are potential high-risk consequences for an event, its organizer(s), all Responsible Persons (RPs), and the local authorities who license them. Not to mention the members of the public, who are simply there to take part and in most cases simply enjoy themselves.



**Below shows the preliminaries and advisories presented by Watchguard International (WIL) to the event organisers, in order to establish the previously issued and in place materials and authority to run last year's event (Farm Fest 2023). In order that a practicable review could easily take place.**

The following was requested prior to re-evaluation by Watchguard International (WIL).

- All previous submitted plans and documents for the previous 2003 event;
- Site plans – Previously issued to check changes;
- Risk assessments – as above; (see also below – must be relevant to current UK and International Threats).
- Fire risk assessments (FRA) - as above; (Note: Fire and rescue should ideally be on site)
- Medical risk assessment – as above; (Medical facilities must be on site and all security must hold valid First Aid). First aid must be capable of major trauma, stabbings, Multiple bleed out kits and cater for multiple injuries).
- Security Company and Safety Staff detailed Assignment Instructions for the event.

**The following assessments we also advised were mandatory due to current foreseeable risk to open air and crowded place events based on current UK & International Threats:**

- Carried weapons (sharps, knives, blunt weapons) chemicals and explosives;
- A robust security program to address a complete timeline of events;
- **Crowded Place Assessment** - ENHANCED TIER DUTY;

**Advisory** - Those with responsibility for qualifying premises with a capacity of **800 people** or more have additional or “enhanced” duties.

**The following was also reviewed with the organisers:**

Establish if the organisers can manage crowd safely for the type of event using the following:

- Identify key hazards affecting crowd safety; hazards from crowd dynamics
- Determine the number of people who will attend
- Assess the venue/site suitability
- Audience profiling
- Assess existing precautions – what more should be done?
- Create a crowd management plan and review plan; put crowd controls in place
- Entering and leaving the venue; entrances and exits; traffic routes vehicle and pedestrian
- Crowd controls inside the venue; viewing areas
- Crowd management staff and command structures
- Communications; monitor the crowd
- Crowd monitoring systems; monitoring numbers; monitoring by your staff
- Other ways of monitoring crowds

**Planning for incidents and emergencies**

- Counter-terrorism
- Sharing plans
- Develop an emergency plan
- Emergency procedures
- First aid, medical assistance and ambulances
- Have clear emergency roles and responsibilities



- Evacuation and Invacuation
- Escape routes and exits
- Signs and lighting to help evacuations
- Places of safety
- Vulnerable people
- Show stop – You must have a show stop procedure...
- Transfer of authority for an emergency/major incident
- Testing and validation

**We discussed in detail the Current Laws in place within the UK and how to comply:**

As the guidance, already exist to ensure that people within the care of duty holders are protected. We also reviewed the event using the following:

- Health and Safety at Work Act 1974; Management of HASAW Act.
- Crime and Disorder Act 1998; and Terrorism Act 2000.
- Anti-terrorism, Crime and Security Act 2001.
- Licensing Act 2003; and Prevention of Terrorism Act 2005.
- Community Safety Partnerships – The Community Safety Partnerships were introduced by Section 6 of the Crime and Disorder Act 1998 which were designed to bring together local partners to formulate and deliver strategies to tackle crime and disorder in their communities. The responsible authorities that make up the Community Safety Partnership are the Police, Fire and Rescue Authority, Local Authorities, Health Partners, and Probation Services.
- ***The outline content and current requirements of Martyn's Law were covered by the entire approach, due the foreseeable implementations of the standards and guidance offered.***

**Conclusions to the preliminaries**

It was established that the previous submitted documents and support offered for the previous year was low of the standards required for the local authorities to sanction the previous event let alone the rapidly approaching (*as of 18<sup>th</sup> August 2024*), Farm Fest 2024 event to be held 7<sup>th</sup> Sept 2024.

***It was immediately established by the owners and organisers of the event that all of the above advisories and previously submitted materials was both inadequate and not available in the manner it should be.***

The owners then took direct and positive action to remedy this by establishing practical arrangements with Watchguard International and its associates to completely review the process and meet all statutory obligations and the expectations of Kirklees MC and those of West Yorkshire Police (WYP).

The owners & organisers embedded themselves from the onset in the safety and security aspects of the event and made this their priority at all levels to ensure the safety and security of any members of the public, any staff or event contractors.

This made the whole process more practicable and fluid.

Liaison and relationships with Local Authorities, Police, NHS, Private medical services, WYF&R services was established and maintained throughout the build and running and the drawdown of the event.

A safety and security consultant (the author) was used throughout and was present during the event to ensure compliance and where practicable that ongoing audits and supervisions were carried out.



## Process Overview – Document & Compliance Library, Development and Issue

18<sup>th</sup> August 2024 – Meeting at Crossley Farm Livery took place.

**It was established:** That a detailed crowded place assessment was required in the first instance. The report was a detailed security and safety assessment of the current security and safety arrangements of Crossley Farm (Farm Fest 2024). It also identified the spectrum of threats of crime and terrorism; which allowed a full evaluation of any associated risks identified. The crime statistics that were used were based on real time national and local crime analysis.

**The Festival Event was viewed as a soft target and crowded place.**

The report as shown on page 4 was initially issued in Draft V1 on the 24<sup>th</sup> August 2024. The initial RAG ratings are shown below.

Due to the sensitive content the final report was issued in hard copy only, for use solely by the owners and organisers; as it exposes the venues full spectrum of vulnerabilities and could be used by an adversary to commit crime if in the wrong hands. The report had high risk values, as shown below. Once adequate mitigations were put in place; the report’s findings were finalised and assessed as tolerable with risks reduced, by actions taken. This is reflected upon and further demonstrated in this report. Refer to the actions table example on page 6 for more details.

**TESTING** - The surveyor/security consultant also carried out detailed adversary reconnaissance to prove and assimilate, types of foreseeable attack scenarios; to review vulnerabilities and enable appropriate mitigating actions to be apportioned to the event, where they were practicable to achieve.

Notes taken from final crowded place report:

The site required a full suite of emergency plans for dealing with the identified acts of terrorism threats and it was documented that there is no means to derogate some attacks methodologies such as VAW due to the make-up of the site and its boundaries. Management of queues was managed effectively due to the threats. Crowded Place management was paramount for this event, especially external areas, entry and exits. To reiterate there was a requirement for robust emergency plans and response plans for all forms of attack. Fire Risk Assessment (FRA) actions were completed along with other identified actions.



# Crowded Place Security & Event Compliance

## Event Summary

There are very few risks in today’s society which are not either foreseeable or predictable, therefore duty holders must make every effort to safeguard people under their care and have the qualified safety and security advice at hand; and also have suitable and sufficient physical manned security and safety arrangements in place to deal with incidents or dilemmas. **We believe this was achieved.**

### Below showing security staff, paramedic and West Yorkshire Fire & Rescue Crew engagement



Regardless of systems and alarms, crowded places (PEOPLE) require physical manning arrangements to both help to protect them and; also deal with the basics of first aid, fire, and other foreseeable emergencies. **We believe this was achieved.**

It must be assumed that people especially those under the influence of alcohol etc; will **NOT** know what to do if an incident occurs. History shows they **WILL** require guidance, instruction and assistance to ensure that any plans in place will work. If not, the plans will fail, and they will be deemed not suitable nor sufficient. **We believe this was achievable.**

Human behaviour shows that most people who enter a venue when an alarm goes off will exit the way they came in as it’s the only route they may associate with. This can be the biggest mistake of an emergency evacuation. People need managing during an emergency. **We believe this was achievable.**

Emergency plans and procedures must reflect the movement and direction of people. **Achieved.**



The next pages of this report focus on the process documentations and the development of a suitable and sufficient suite of compliance materials to enable an event to run.

These are based on all aspects of the HASAW Act 1974 and any associated materials needed for referral to run the Farm Fest 2024 only. It must be stated that this was not a business review of Crossley FARM Livery, but a review for the requirements of the event being held on land owned and managed by the organisers. The following are based on the Festival Event and not the separate Farm & Livery business.

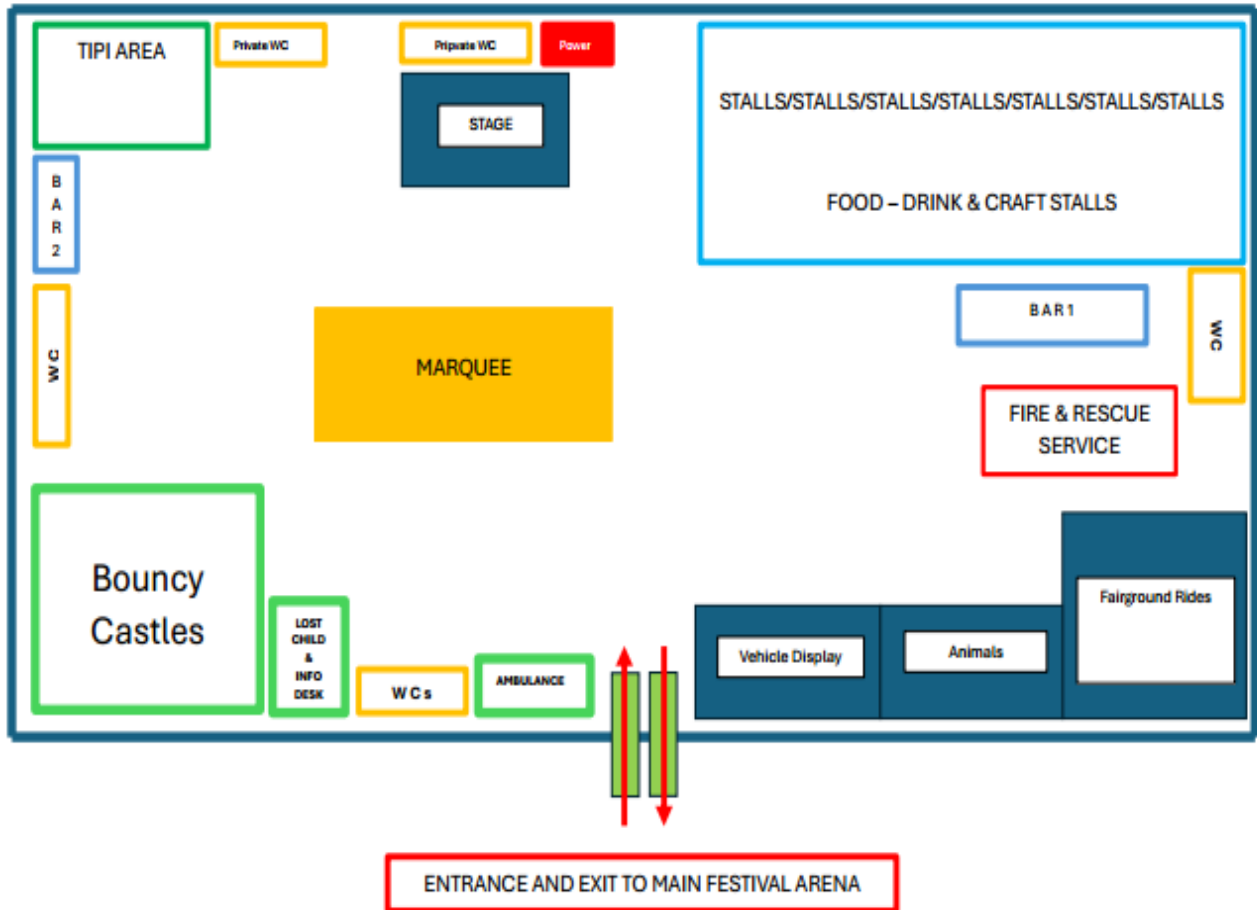

Process overview – The event 5<sup>th</sup>, 6<sup>th</sup>, 7<sup>th</sup> September 2024

The main event was effectively built over the periods as shown above.

The first phase was to ensure that the perimeter fence was established and all relevant stalls and facilities were in place as per the requirements of the site plan or within practical means.

Albeit a few minor amendments the event was established as was intended by the plans shown.

**7<sup>th</sup> September 2024 – 1130hrs** the event was ready to open in all respects.

Security and Stewards brief was carried out in order to ensure that all relevant staff were briefed on the emergency plans for any incidents and the traffic management plan was put in place.

Security and Stewards were then placed at critical positions as shown on the TMP. (Page 11).

**Minor Action Point** - Although only a minor administrative issue, which was resolved at the time. It was identified that security and stewards should have been there an hour earlier to ensure early briefing and early deployment to critical security control points as per the TMP, due to early arrivals and last-minute logistics. **This should be factored in for next year.**



### Traffic Management Plan



#### Perimeter Security - Access and Egress

The perimeter was intended to have the main entrance as shown below as the only means of pedestrian entry and exit.

Below showing pedestrian entrance & exit to the main arena area which was controlled by security.



**Queue Management** - Entry and exit was managed in a robust efficient manner to ensure safety and to impose search criteria as part of the admissions policy and in relation to known threats.

There was no general complaints from customers about how this was managed and all arrivals appeared content with the process and even complimented staff and management on the safety protocols, being employed.

Contraband found was limited to a few drinks and food items and no resistance was met when challenged. Customers were appreciative of the process.

It will also identify the threats of crime and terrorism and allow evaluation of any associated risks which are identified. The crime statistics used are based on real time national and local crime analysis. **Any Festival or open-air Event is viewed as a soft target and crowded place.** Any risks or hazards identified which refer to any potential terrorism events are realistic to the current UK and International threat. It is advised that in this survey report that the organizers and duty holder adopt the “risk-based approach” as it allows the organizers to review and balance each identified risk and respond with agility applying any required improvements in a sensible manner where they are practicable to achieve. This is not aimed at undermining any legal duties of the duty holder(s) to ensure where practicable the health, safety, and welfare of all people they are ultimately responsible for; but simply reflects the principles of cost verses risk in its practical terms. This report in its entirety also aims to provide relevant parties practical advice and actions to also meet their obligations to the statutory requirements of Law; and that of any crowded place guidance, required for the event and its facilities.

Recommendations both appropriate and proportionate are security measures for compliance where practicable to the health and safety requirements of the duty holder(s).

The report will also act as an Operational Requirement (OR) to work with emergency plans and procedures and any security assignment instructions (AI's) in place; as part of the overall integrated security and safety portfolio for the event and any insurance caveats issued.
