IMPORTANT INFORMATION

- All prices listed on www.huallpajoyas.com do not include the 18% VAT tax (exports are exempt from this tax).
- Orders must be placed via email or WhatsApp. You may review our catalogs, where you will find the codes and approximate weight of each product.
- The silver gram value will be calculated on the day your order is placed.
- The minimum export order is 500 grams (1/2 kilogram) and 5 units per design.

We continuously work to ensure our product photographs accurately represent the jewelry. Since all pieces are handmade, slight variations in color may occur. The appearance of stones and color tones may vary depending on the monitor, digital device, or operating system used. Please remember these are natural materials with a wide range of color variations.

MINIMUM ORDER REQUIREMENTS

HUALLPA applies minimum order quantities by unit and color customization.

CUSTOM COLORS, EXCLUSIVITY, AND PAYMENT TERMS

CUSTOM COLORS.

We accept up to a maximum of 50% customized colors per order, with a minimum of 3 units per color and design.

DESIGN EXCLUSIVITY.

For designs not originally created by Huallpa and provided by clients, we maintain strict exclusivity and confidentiality to protect your designs. We commit not to reproduce these designs for third parties. Any piece submitted and designed by the client remains exclusively between Huallpa and the client.

PAYMENT TERMS.

An advance payment of approximately 50% is required to begin production.

The remaining balance must be paid before shipment or delivery, along with any additional costs if applicable (shipping, certifications, or related expenses).

PAYMENT METHODS.

For international clients, payments may be made in U.S. dollars or Peruvian soles.

Payments can be made securely through bank transfer (USD or PEN), Western Union, Ria, online banking, or any other payment method agreed upon with us. All payment methods are handled with maximum security.

SHIPPING AND RETURNS

DOMESTIC SHIPPING.

Domestic shipments within Peru are made through Olva Courier, Shalom, or an interprovincial delivery agency, depending on the agreement reached between Huallpa and the client.

INTERNATIONAL SHIPPING.

You may choose the shipping method according to updated Incoterms, including pickup at the production workshop, delivery to your designated contact person, local delivery within Peru, or international courier services such as DHL, SerPost, UPS, or FedEx to the destination country.

We provide all documentation required by customs authorities.

Shipping times vary depending on the courier company and destination country. Please consult with us or your shipping agent before placing the order..

RETURNS.

We recommend reviewing the products before completing your purchase. However, if the products were shipped to your address or if you are located outside Peru, you have up to 10 calendar days from the date of receipt to report any issue and coordinate a return. Please contact us directly via WhatsApp or email explaining the reason for the return or exchange.
