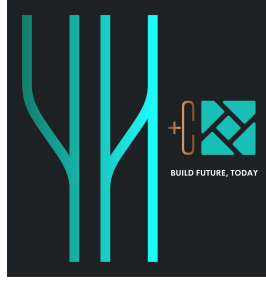


## **YHC, YHCO & IMCCo. Environmental Policy Statement**

- **Use Energy and water efficiently** during the project process and promote conservation of natural resources.
- **Minimise waste**, by recycling and reusing materials where possible and being proactive in the reduction of waste.
- **Ensure that all employees are aware of environmental issues**, the environmental impacts of our business operations and activities and what they are expected to contribute to minimise our environmental impact. This is done by a combination of training, communication and the Companies' working practices.

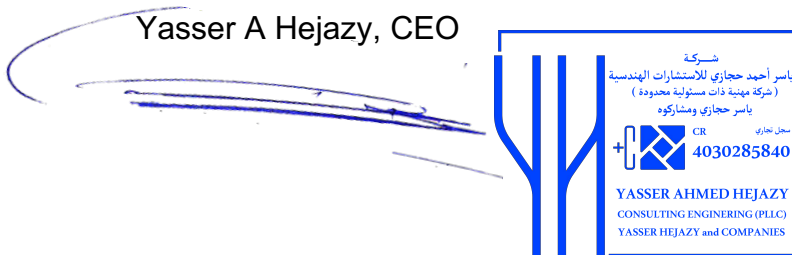


- **The setting of annual environmental objectives** and targets to measure improvements in environmental performance.
- **Ensuring that our Subcontractors and Suppliers** are aware of our Policy and encourage them to apply similar environmental standards to their own works.
- **Monitoring Coral bleaching warning protocol**. Should a NOAA Bleaching Warning be issued for the area, corals on reefs next to work areas should be assessed every fortnight. If a NOAA Bleaching Alert Level 1 is issued for the area, or if daily average sea surface temperatures exceed 1°C above modelled monthly mean temperature corals should be assessed on a weekly basis. If a NOAA Bleaching Alert Level 2 is issued for the area or if temperatures exceed 2°C more than the modelled monthly mean temperature if corals should be assessed on a daily basis.

**YHC, YHCO & IMCCo.** shall participate in open consultation with interested stakeholders, local communities and ensure effective communication of this Environmental Policy to all those working for and on behalf of the Company.
