
- <u>Comply with and whenever possible exceed all applicable Environmental</u> <u>Legislation and regulatory and other requirements</u>. The Company will regularly evaluate its compliance with the relevant legislation and will utilise Government Guidance and Industry Codes of Best Practice, to help achieve this.
- <u>Continually improve our Business Management System</u> processes and documents by regular measurement, review and audit and the implementation of improved measures to prevent pollution and minimise environmental impact.
- <u>The use and practice of a Sustainable Procurement Policy</u>, ensuring packaging is minimised, sustainable products are sourced, and local suppliers preferred. To continue to develop trading relationships with suppliers committed to similar environmental objectives.
- <u>Use Energy and water efficiently</u> during the project process and promote conservation of natural resources.
- <u>Minimise waste</u>, by recycling and reusing materials where possible and being proactive in the reduction of waste.
- Ensure that all employees are aware of environmental issues, the environmental impacts of our business operations and activities and what they are expected to contribute to minimise our environmental impact. This is done by a combination of training, communication and the Companies' working practices.



- <u>The setting of annual environmental objectives</u> and targets to measure improvements in environmental performance.
- Ensuring that our Subcontractors and Suppliers are aware of our Policy and encourage them to apply similar environmental standards to their own works.
- Monitoring Coral bleaching warning protocol. Should a NOAA Bleaching Warning be issued for the area, corals on reefs next to work areas should be assessed every fortnight. If a NOAA Bleaching Alert Level 1 is issued for the area, or if daily average sea surface temperatures exceed 1°C above modelled monthly mean temperature corals should be assessed on a weekly basis. If a NOAA Bleaching Alert Level 2 is issued for the area or if temperatures exceed 2°Cmore than the modelled monthly mean temperature if corals should be assessed on a daily basis.

YHC, YHCO & IMCCo. shall participate in open consultation with interested stakeholders, local communities and ensure effective communication of this Environmental Policy to all those working for and on behalf of the Company.
