VA	General Coal Miner (GCM)	AFA	Board of Coal Mining Examiners	Meets requirements. Regulation states: "...First aid shall be included in the general coal miner training unless applicants submit new miner training or annual refresher training to meet first aid requirements."

Regulation states: "At all times that juveniles are on any premises where alternative day treatment or structured day programs are provided, there shall be at least one qualified person actively supervising who has a current first aid and CPR certification."

Regulations require: "Current certification in advanced resuscitative techniques with hands-on simulated airway and megacode training for health care providers, including basic electrocardiographic interpretations, such as courses in ACLS or PALS."

Regulation states: "Doctors who utilize office-based anesthesia shall ensure that all medical personnel assisting in providing patient care are appropriately trained, qualified and supervised, are sufficient in numbers to provide adequate care, and maintain training in basic cardiopulmonary resuscitation."

First aid and cardiopulmonary resuscitation, unless the individual is currently certified, with certification required as applicable to their duties..."
