

Notice of Filing Instructions

The attached Notice of Filing must be posted on the same day as or within 30 days before filing the LCA.
PLEASE POST THE ATTACHED NOTICE ON THE SAME DAY YOU RECEIVE IT FROM OUR OFFICE.

If posting electronically:

- 1) Copy and paste the text of the attached notice:
 - a) **Into an email** and send to all employees in the same or similar position (including company employees and employees of the end-client at the work site, if applicable); **OR**
 - b) **Into a company intranet posting**-the intranet posting must be available for viewing for **10 consecutive calendar days.**

If posting physically:

- 2) Print **TWO** copies of the attached notice for **EACH** work location listed on the LCA.
 - a. Example: John Doe will work at our office at 12345 Way, San Francisco CA 94105 and a client site located at 54321 Street, Daly City, CA 94015. A total of 4 notices must be posted, 2 at each location.
 - b. Please post each Notice in a different specific area at the work location(s) (for example- conference room, kitchen, notice boards, etc.) for **10 consecutive calendar days.**
