1. Information We Collect

1.3 Information from Third Parties

We may receive information about you from:

Analytics providers that help us understand Site traffic and usage patterns.

2. How We Use Your Information

We use the information we collect for purposes such as:

Legal Requirements: If required to do so by law or in good faith belief that such action is necessary to comply with legal obligations, protect or defend our rights or property, or protect the safety of users or the public.

We do not sell your personal information for monetary compensation. If applicable laws (such as some US state laws) treat certain sharing as a "sale," we will comply with those requirements and provide any required opt-out mechanisms.

When information is no longer needed, we will delete or anonymize it in accordance with our data retention practices and applicable laws.

7. Data Security

We use reasonable administrative, technical, and physical safeguards to protect your personal information from unauthorized access, disclosure, alteration, or destruction. However, no method of transmission over the Internet or method of electronic storage is 100% secure, and we cannot guarantee absolute security.

8. Your Privacy Rights
