Minister's Report

Another year gone by.

The year brought the unexpected (Anna and I purchasing a home. Never thought I would *ever* become a homeowner).

The year brought joy, innumerable causes for celebration: weddings, anniversaries, birthdays, and births. Of course, there were somber periods; funerals and other hardships faced by the community of faith and the broader community.

But it was also a year of firsts.

The church held its Annual Meeting on April 03rd. This was our first annual meeting together and my *first* Annual Meeting as an ordained minister.

In addition to Sunday worship services, I officiated eleven funerals and one wedding. Tracey and Cody Hedin were wed on June 11th. It was my first time officiating a wedding (and the only one to date). It was a beautiful day full of love and happiness. The couple exchanged heartfelt vows. May God continue to bless their union.

I was invited to participate in events in the broader community. Gina invited me to be one of the judges for the 4H Speaking Competition, held on February 27th. I was in awe of the immense talent of the youth. In light of the immense talent involved, the judges had a *very* difficult time in determining the winner.

As the United Church of Canada remains committed to reconciliation, my family and I attended the Truth and Reconciliation Candle Light Vigil on September 29th. A Residential School survivor spoke, bravely sharing their story, opening up their heart, voicing the hurt they had experienced.

I remained involved with the Church Yard Sale Committee. The church held two Yard Sales: May 28th and October 21st.

I would like to express my heartfelt thanks to all of the committee members, as well as all of the congregants who volunteered their time and effort in assisting with these great endeavors. Without all of your help, the church would not have been able to hold such important fundraisers.

The year was also difficult for my family and me. My family is immunocompromised, and as a result, we caught COVID-19 (three times) which forced my family and I to isolate. It was a period of struggle as I wanted to be in the church, serving the community, but illness restricted/prevented me from doing so.

In exciting news, the church came out with a new photo directory. I was asked to provide the minister's message. The photo directory still brings a smile to my face; the pictures tell stories of joy and happiness.

I was also able to attend other community events/celebrations.

I attended the Christmas Tea & Bazaar, which was held on December 03rd. I offered an opening prayer, and officially opened the bazaar. My son, Sam and I agreed, the pie was delicious! I purchased a delicious lemon meringue pie (which I did not share).

I was approached by the Fedusiak Funeral Chapel to provide a prayer and reflection for their annual Blue Christmas Service on December 06th. The service was closed to the public (due to COVID-19), and streamed on the Funeral Chapel's website.

We celebrated another Christmas season together.

The youth led the White Gift Service (December 11th). All of the talented children and young adults did a fantastic job (and Elvis made a special appearance).

In terms of education, I was excited to begin Bible Study. The first session was on October 06th. We have great discussions and I enjoy it immensely. The sessions continue to be held every Thursday at 10 AM. All are welcome.

Of course, not everything went off without a hitch.

Gary Clarke and I collaborated in forming a communal support group, SEW (Spirit Empowered Well-being).

We spent many hours crafting and formulating the program. It was an entirely enjoyable experience and I learned a lot. However, there was a lack of interest and the group was canceled. However, as Gary remarked, "nothing ventured, nothing gained."

In closing, I look forward to what the future brings. As of this writing, we are planning on beginning Confirmation classes, youth events, discerning becoming an Affirming Ministry, and community outreach through involvement in the Homelessness Committee and Harm Reduction Committee.

Pastoral Care

The Pastoral Care Team meets twice monthly on Tuesday at 1:00 pm. with our minister Rev. Jon Worrall. We generally discuss the concerns of members of our church family who are being hospitalized, dealing with health problems, residing in or moving into care homes or other challenges where we can offer help, encouragement or some kind of support such as personal and telephone visits or sending cards. All concerns shared with the team are kept confidential. We have church members in the care homes in Melfort, Kinistino, St. Brieux, Weldon, and Tisdale.

Due to the pandemic, COVID 19, and this year, Influenza and Flu, our contacts and visits have mainly been by telephone, or by sending cards as personal visits have not been permitted (except by immediate family members) for much of 2022.

The team depends on congregational or family members to keep us abreast of the needs and concerns of our church families. Contact can be made through the church office, with any member of the team or directly with our minister, Rev. Jon Worrall. Jon would welcome a visit from any of you.

We want to sincerely thank those in the congregation who visit regularly (either by phone or in person) with shut-ins or others in our community. It is especially important during the pandemic for folks to be remembered and let them know we care.

Property Committee

The Property Committee has had a busy year, accomplishing several special projects in addition to the handling ongoing needs such as changing lightbulbs in both the sanctuary and CE Centre, repairing a sanctuary blind and general maintenance. Harvey and Ryan Heavin climbed onto the top of the flat roofed CE Centre to clean the eavestroughs in the spring. Kelly repaired a play school bookshelf that had been damaged during a break in.

The special projects completed in 2022 are:

- I) Repaired damaged areas and drains on the flat roof of the CE Centre.
- Work done by Clark's Roofing in PA.
- 2) Ordered new toilets for the basement washrooms from Home Hardware.
- 3) Arranged for the removal of damaged tiles in the foyer entrance, basement hallway and two basement washrooms. Work done by Bob Smith in PA.
- 4) Replaced the removed tiles with high quality linoleum. Lino and work by Foulliards in Melfort.
- 5) Replaced the window in the minister's office. Work done by Tower Glass in Melfort.
- 6) Organized the repair of the outside steps leading to the CE Centre.

There are some potential 2023 projects that we are looking into:

- 1)Replace main entrance steps and remove ramp.
- 2)Repair bell tower.
- 3)Repair and paint water damage spots.

Our committee has been happy to serve the needs of our church.

Trustee's 2022 Report

The current members of the Melfort United Church Board of Trustees for 2022 are: Dorothy Busby (Chairperson), Marion Heavin (Secretary), Bill Koroluk, Doug Lyon, Ron Nielsen and Jim Stevenson.

The role of the trustees is to oversee all buildings and properties of Melfort United Church. This includes the responsibility of ensuring that adequate insurance coverage is in place. The trustees have the authority to sell surplus items that are housed in the church building. We inspect the buildings and property at least twice annually, review the insurance policy annually (with the Property Committee) and report to the official board of Melfort United Church regularly.

Concerns during 2022 include:

- exterior west wall of the sanctuary-Property committee is aware and is continuing the search for companies and /or individuals with masonry expertise to consider the repair.
- work was completed on the roof of the Christian Education Center where water damage had occurred and eave troughs were cleaned.
- Water damage was also repaired in the administration office and in the C.E. Center.
- Windows were replaced in the minister's office (three windows were replaced with two)
- there was asbestos concerns around chipped tile and pipes in the C.E. Center basement and the main entrance. The Property Committee dealt with it but are awaiting the completion of the inspection.
- repair is in progress in the bell tower(water leakage)
- the roof in the small storage shed north of the sanctuary will need replacing in the spring.
- several of the toilets have been replaced.
- Playschool notifies the office when they have concerns.
- Major change in the main entrance is being considered.

The trustees cleaned the C.E. Center furnace room, a storage room next to the elevator and tidied the Library.

We recognize that we are maintaining an older building that is requiring considerable remedial upkeep and repair. Our thanks goes out to the Property committee as this places considerable demand on them.

Our thanks goes to our custodian, Caleb Hubbell, for his role in maintaining our church. Thanks also to Lorne Anderson for continuing to monitor the humidifiers in the pianos and to Bill Koroluk for continually inspecting the water fountain. Thanks to Women Alive for maintaining the flower beds.
