The following report is submitted by: PTL DAVID F. MACKENZIE JR.

ON 5-13-19 CAR 1 MACKENZIE RESPONDED TO THE LOBBY FOR A REPORT. I SPOKE WITH SEAN VENTI WHO STATES THAT HE IS SEPARATED FROM HIS WIFE CHRISTINE AND HAS BEEN STAYING IN LUNENBURG.
