*** NARRATIVE ***

The following report is submitted by: PTL ROBERT J. MURPHY JR.

ON 05/20/19 AT APX. 2:15 PM WHILE ASSIGNED TO AREA CAR #1, I (PTL. R. MURPHY) RESPONDED TO THE LOBBY OF THE CHELMSFORD POLICE STATION TO SPEAK TO A PARTY ABOUT ISSUES HE IS HAVING WITH HIS WIFE.

I ARRIVED AND SPOKE TO SEAN VENTI. SEAN EXPLAINED THAT HE IS IN THE PROCESS OF GETTING A DIVORCE FROM HIS WIFE, CHRISTINE VENTI. THERE HAVE BEEN 4 CALLS FOR SERVICE INVOLVING SEAN AND CHRISTINE VENTI IN THE PAST 8 WEEKS. (CASE #712236, 717798, 719555, AND 720162) THERE ARE NO PROTECTIVE ORDERS IN EFFECT, AND NO COURT ORDERED CUSTODY ARRANGEMENTS AT THIS TIME. BOTH SEAN AND CHRISTINE HAVE BEEN STAYING AT THE HOME ON AND OFF AGAIN, WITH THEIR 3 YOUNG CHILDREN. SEAN HAD LEFT FOR A SHORT TIME, BUT HAS RETURNED TO THE HOME.

SEAN VENTIS MAIN CONCERN TODAY WAS THAT YESTERDAY (05/19/19) AT APX. 10:45 AM CHRISTINE WAS SENT TO EMERSON HOSPITAL FOR AN INVOLUNTARY COMMITMENT (SEC. 12) BY OFFICERS OF THIS DEPARTMENT FOR HAVING MADE SUICIDAL COMMENTS. CHRISTINE'S MENTAL HEALTH APPARENTLY IMPROVED GREATLY OVERNIGHT, AND SHE WAS RELEASED FROM THE CARE OF EMERSON HOSPITALS PSYCHIATRIC UNIT TODAY (05/20/19). SEAN STATED THAT CHRISTINE CALLED HIM DEMANDING A RIDE HOME FROM EMERSON HOSPITAL. SEAN VENTI'S ISSUE IS THAT HE IS CONCERNED ABOUT CHRISTINE'S MENTAL HEALTH, AND WORRIED ABOUT HIS CHILDREN BEING IN HER CARE IF SHE IS UNSTABLE. SEAN STATED THAT HE PLANS ON STAYING AT THE HOME, BUT IS WORRIED THAT CHRISTINE MAY GET ANGRY WITH HIM AND FILE A FALSE REPORT OF ABUSE BY HIM. SEAN TOLD ME THAT HE HAS A JOB THAT REQUIRES MILITARY CLEARANCE, AND HE CAN NOT HAVE ANY LEGAL ISSUES AS IT COULD JEOPARDIZE HIS JOB.

I ADVISED SEAN THAT HE SHOULD DISCUSS THESE ISSUES WITH HIS LAWYER, AND ASK FOR DIRECTION FROM THE LAWYER ON HOW TO PROCEED. I ALSO ADVISED SEAN THAT HE WILL NEED TO BE ON HIS BEST BEHAVIOR WHILE IN THE HOME WITH CHRISTINA, AND AVOID ANY INFLAMMATORY CONVERSATION TOPICS. I ADVISED SEAN TO CALL THE POLICE IF CHRISTINE'S MENTAL HEALTH BECOMES AN ISSUE, OR THERE ARE ANY OTHER ISSUES THAT ARISE.
