*** NARRATIVE ***

The following report is submitted by: PTL RYAN F. CALLAHAN

ON 5/24/19 AT 0958 HRS., I, OFFICER CALLAHAN AND OFC. SECH, WHILE ASSIGNED CAR #22 ON THE 0800-1600 SHIFT, RESPONDED TO THE LOBBY OF THE STATION FOR LEGAL ADVICE.

UPON ARRIVAL, WE MET WITH CHRISTINE VENTI, WHO WAS LOOKING FOR INFORMATION REGARDING THE DISSOLUTION OF HER MARRIAGE. CHRISTINE AND HER HUSBAND, SEAN VENTI, ARE GOING THROUGH THE DIVORCE PROCESS. THE PROCESS HAS BEEN TUMULTUOUS AND DIFFICULT FOR BOTH OF THEM. IT SHOULD BE NOTED THE CHELMSFORD POLICE DEPARTMENT HAS TAKEN MULTIPLE REPORTS/RESPONDED TO CALLS REGARDING CHRISTINE AND SEAN SINCE MARCH 2019 (3/2/19 - 712236, 4/27/19 - 717798, 5/13/19 - 719555 & 5/20/19 - 720278).

THERE WAS A MUTUAL AGREEMENT BETWEEN CHRISTINE AND SEAN THAT HE WOULD MOVE OUT. CHRISTINE STATED THAT SEAN WAS STAYING WITH A FRIEND IN LUNENBURG.

SEAN BEGAN SLEEPING BACK AT THE HOUSE (10 COACH RD) TO TAKE CARE OF THE KIDS. (BOTH CHRISTINE AND SEAN'S NAME IS ON THE DEED). SEAN BEING BACK AT THE HOUSE HAS CREATED MORE TENSION AND DISAGREEMENTS BETWEEN THE TWO OF THEM. CHRISTINE SPOKE ABOUT POSSIBLY CONSIDERING A RESTRAINING ORDER. CHRISTINE STATED HER AND SEAN HAVE A COURT DATE IN PROBATE COURT ON 6/2/19 FOR A TEMPORARY ORDER HEARING.

CHRISTINE SEEMED UNCERTAIN IF A RESTRAINING ORDER IS THE ROUTE SHE WANTED TO TAKE. IT SHOULD BE NOTED THERE CURRENTLY ARE NO COURT ORDERS REGARDING SEAN AND CHRISTINE (THE HOUSE, KIDS, MONEY, ETC). I SPOKE WITH CHRISTINE ABOUT POSSIBLY MEETING WITH SEAN IN A NEUTRAL LOCATION (IE: COFFEE SHOP) TO DISCUSS THEIR FUTURE INTERACTIONS AND LIVING ARRANGEMENTS. CHRISTINE SEEMED OPEN TO THE IDEA AND STATED SHE WOULD GIVE IT A TRY. CHRISTINE WAS STILL ADVISED OF HER 209A RIGHTS AND PROVIDED WITH A DEPARTMENT ABUSE LAW CARD (SIGNED). CLEAR.
