The following report is submitted by: PTL. CRAIG K. MEAD

ON 5/24/19 I, OFFICER MEAD, WAS ASSIGNED TO THE MOTORCYCLE ON THE 1600-0000 SHIFT. AT APPROXIMATELY 1802 HOURS, I RESPONDED TO 10 COACH ROAD FOR LEGAL ADVICE ON A HARASSMENT PREVENTION ORDER.

UPON ARRIVAL, I MET CHRISTINE VENTI. CHRISTINE IS THE PLAINTIFF IN HARASSMENT ORDER DOCKET NUMBER 1911R0723. THE DEFENDANT, SEAN VENTI, IS HER SOON TO BE EX HUSBAND. SHE WAS GRANTED A HARASSMENT PREVENTION ORDER TODAY BY LOWELL DISTRICT COURT, WHERE SEAN IS STILL ALLOWED TO CONTACT HER. TODAY, SEAN WAS TEXTING HER TRYING TO WORK THINGS OUT BUT NOTHING MALICIOUS OR THREATENING WAS SAID. I TOLD CHRISTINE I WOULD DOCUMENT THIS FOR HER AND TO CALL IF THERE ARE ANY OTHER QUESTIONS IN THE FUTURE.
