### \*\*\* NARRATIVE \*\*\*

The following report is submitted by: PTL. KALEIGH YUAN

ON 05/28/2019, I, OFC. YUAN WAS ASSIGNED TO CAR 1 ON THE 1600-0000 SHIFT. AT 17:33 HRS, I RESPONDED TO 10 COACH RD FOR A VERBAL DOMESTIC. CAR 3, OFC. MEAD AND CAR 9, SGT. GOODE ALSO RESPONDED TO THIS CALL.

UPON MY ARRIVAL, MALE PARTY SEAN VENTI WAS STANDING OUTSIDE BY HIS CAR, AND CHRISTINE VENTI WAS INSIDE WITH THEIR CHILDREN. OFC. MEAD AND SGT. GOODE SPOKE OUTSIDE WITH SEAN WHILE I SPOKE WITH CHRISTINE INSIDE. IT SHOULD BE NOTED THAT THEIR CHILDREN RYKER VENTI, BRADAN VENTI, AND BREENAH VENTI WERE PRESENT DURING THE ALTERCATION.

CHRISTINE TOLD ME THAT HER AND SEAN HAVE BEEN HAVING ON-GOING MARTIAL ISSUES. SEAN WORKS OVERSEAS IN THE MILITARY, AND CHRISTINE IS A HOMEMAKER. CHRISTINE HAS BEEN HAVING ISSUES WITH HER MENTAL HEALTH, AND REPORTS SEAN TO NOT BE SUPPORTIVE OR UNDERSTANDING, LABELING HER AS A BAD PARENT. CHRISTINE WAS ISSUED A HARASSMENT ORDER AGAINST SEAN OUT OF LOWELL DISTRICT COURT ON 05/24/19 (DOCKET #1911R0723). THE HARASSMENT ORDER STATES TO NOT ABUSE CHRISTINE. THERE ARE NO STIPULATIONS STATING SEAN CANNOT BE AT 10 COACH RD AND NOTHING STATING HE CANNOT CONTACT CHRISTINE.

CHRISTINE TOLD ME THAT THIS EVENING, SHE WAS IN CONVERSATION WITH SEAN VIA TEXT IN REGARDS TO HER SON BRADAN VENTI'S KARATE CLASS. SEAN WAS ORIGINALLY SUPPOSED TO TAKE BRADAN TO KARATE, BUT "GAVE CHRISTINE ATTITUDE" ABOUT IT. CHRISTINE TEXTED SEAN, AND ASKED HIM TO NOT COME TO THEIR HOUSE, AND THAT SHE WOULD BRING BRADAN TO KARATE HERSELF. SEAN RECEIVED AND READ THE MESSAGE AT 17:05, AND PROCEEDED TO GO TO 10 COACH RD DESPITE CHRISTINE'S WISHES. IT SHOULD BE NOTED SEAN STILL LEGALLY LIVES AT 10 COACH RD, BUT CURRENTLY RESIDES WITH A FRIEND TO PREVENT ANY SORT OF VOLATILE SITUATIONS BETWEEN HIM AND CHRISTINE. CHRISTINE WAS UPSET UPON SEAN'S ARRIVAL AND THE TWO BEGAN TO ARGUE. CHRISTINE WAS ATTEMPTING TO WORK THINGS OUT WITH SEAN ABOUT THEIR MARITAL ISSUES AND PARENTAL RIGHTS/OBLIGATIONS. IT SHOULD ALSO BE NOTED THAT THE TWO HAVE MADE A MUTUAL AGREEMENT TO ONLY SPEAK ABOUT THE CHILDREN. SEAN DID NOT WISH TO SPEAK TO CHRISTINE ABOUT THEIR ISSUES, ESPECIALLY IN FRONT OF THE CHILDREN. CHRISTINE CALLED THE POLICE DUE TO THE HARASSMENT ORDER IN PLACE, AND REQUESTED THAT SEAN LEAVES.

AFTER SPEAKING WITH CHRISTINE, I WALKED OUTSIDE TO SPEAK WITH OFC. MEAD AND SGT. GOODE TO INFORM THEM OF MY FINDINGS. OFC. MEAD INFORMED ME THAT SEAN REPORTED THAT CHRISTINE GRABBED HIS FOREARM TO GUIDE HIM OUTSIDE WHILE TELLING HIM TO LEAVE. SEAN TOLD CHRISTINE TO NOT TOUCH HIM, AND HE DID NOT TOUCH HER BACK. AFTER OFC. MEAD SPOKE WITH SEAN, IT APPEARED THAT WHEN CHRISTINE GRABBED SEAN, SHE WAS NOT DOING SO AS A MALICIOUS ATTACK DUE TO THERE BEING NO SIGNS OF INJURY (REDNESS OR SCRATCH MARKS. SEAN ALSO TOLD OFC. MEAD THAT HE DID NOT BELIEVE CHRISTINE WAS TRYING TO HURT HIM.

MYSELF AND SGT. GOODE RE-ENTERED THE HOUSE TO SPEAK FURTHER WITH CHRISTINE. SGT. GOODE ADVISED CHRISTINE THAT SHE SHOULD NOT PUT HER HANDS ON SEAN, EVEN IF SHE WAS TRYING TO GUIDE HIM OUT OF THE DOORWAY. HE ALSO RECOMMENDED THAT SHE NOT CONTACT HIM IN REGARDS TO HER MENTAL HEALTH ISSUES OR THEIR MARTIAL ISSUES, LIKE SEAN HAD WISHED SINCE THEY HAVE COURT ON 06/03/19 TO DISCUSS SUCH WITH REPRESENTATION. CHRISTINE BECAME UPSET, AND TOLD US SHE JUST WANTED SEAN TO LEAVE. SGT. GOODE SPOKE WITH SEAN, AND SEAN AGREED IT WOULD BE IN EVERYONE'S BEST INTEREST TO STAY WITH HIS FRIEND FOR THE NIGHT. SEAN SAID GOODBYE TO THE CHILDREN, AND GATHERED SOME BELONGINGS. OFC. MEAD READ HIM HIS 209A RIGHTS (SIGNED AND DATED), AND SEAN GOT IN HIS MV AND LEFT. I READ CHRISTINE HER 209A RIGHTS (SIGNED AND DATED),

I TOLD CHRISTINE TO CALL US BACK WITH ANY OTHER ISSUES SHOULD THEY ARISE. SHE SAID SHE WOULD. AT 20:00 HRS I FILED A 51A WITH SHAKIA FROM LOWELL DCF. A COPY OF MY REPORT WILL BE FAXED OVER TO THE LOWELL DCF OFFICE. CLEAR.
