#### \*\*\* NARRATIVE \*\*\*

The following report is submitted by: PTL TIMOTHY BOURKE

ON 6-1-19 AT APPROX. 18:19 I , BOURKE (C1) AND MELISI (C4) , RESPONDED TO #10 COACH ROAD FOR THE DOMESTIC ARGUMENT. UPON ARRIVAL I SPOKE TO SEAN VENTI AND HE TOLD ME THE FOLLOWING.

SEAN STATED THAT HIM AND HIS WIFE , CHRISTINE VENTI , ARE IN THE PROCESS OF GETTING A DIVORCE. SEAN STATED RECENTLY THEY HAD THEIR OWN ATTORNEYS DRAW UP SOME PAPERWORK WHICH LISTED DATES AND TIMES FOR VISITATION. TONIGHT THE PAPERWORK STATED THAT SEAN COULD VISIT THEIR CHILDREN FROM 5PM TO 9PM. HE ALSO STATED THAT THIS PAPERWORK STATED HE COULD VISIT THE CHILDREN ON 6-2-19 BETWEEN THE HOURS OF 5PM AND 8PM. SEAN STATED THAT WHEN HE SHOWED UP TONIGHT CHRISTINE BEGAN ARGUING WITH HIM. HE STATED THAT CHRISTINE TOLD HIM SHE WAS NOT GOING TO LET HIM SEE HIS CHILDREN. SHE THEN TOLD HIM THAT HE HAD TO LEAVE. SEAN CALLED CPD AT THIS POINT .I ASKED SEAN IF THE ARGUMENT EVER TURNED PHYSICAL. HE STATED THAT CHRISTINE DID TRY TO GRAB HIS PHONE FROM HIS HAND.

AFTER I SPOKE TO SEAN I SPOKE TO CHRISTINE. CHRISTINE STATED THAT HER AND SEAN DID HAVE SOME PAPERWORK DRAWN UP BY THEIR LAWYERS WHICH STATES DATES AND TIMES FOR VISITATION. (TONIGHT BETWEEN 5PM AND 9PM BEING ONE OF THEM) CHRISTINE STATED THAT SEAN BEGAN RECORDING HER WITH HIS CELL-PHONE WHEN HE ARRIVED TONIGHT. CHRISTINE STATED THAT SHE FELT SEAN WAS RECORDING HER TO MAKE HER LOOK BAD IN COURT. CHRISTINE STATED THAT HER AND SEAN THEN ARGUED OVER THIS MATTER. I ASKED CHRISTINE IF SHE EVER PHYSICAL TOUCHED SEAN. SHE STATED SHE GRABBED FOR SEAN'S PHONE BECAUSE SHE WANTED HIM TO STOP RECORDING HER. (NO INTENT TO ASSAULT)

SEAN AND CHRISTINE HAVE A COURT DATE ON MONDAY AT THE CAMBRIDGE FAMILY COURT. I ADVISED THEM THAT I WOULD DOCUMENT THIS INCIDENT FOR THEIR RECORDS. THEY STATED THEY UNDERSTOOD.

I ADVISED CHRISTINE OF HER 209 RIGHTS AND GAVE HER A CPD 209A CARD. THE SIGNED COPY IS ATTACHED TO THIS REPORT. SEAN LEFT THE AREA AND WE CLEARED.

I WILL BE FILING A 51A BECAUSE THE 3 CHILDREN , BREENAH , BRAYDEN AND RYKER VENTI , WERE PRESENT DURING THE ARGUMENT.
