I'm not sure if all, one or none of you are encouraging Sean to use his "63 year old aunt" as an excuse to not have my children return to in school learning because he's too unwilling to drive and would rather "risk" exposing his own family than commute his kids.

I drove to Chelmsford for remote learning and it sucks but it's the reality we are in. Things are hard enough. Please stay out of our parenting plan.

It's obvious this is a game with Sean and any of you encouraging him. This only creates more tension and conflict for us and the kids. Please stop involving yourselves if you are.

Here is a reminder I sent to Sean today about his supposed concerns and his own lack of social distancing and mask wearing.

The kids told me they would be trick or treating with you all and I hope you all are responsible tonight in regards to mask wearing and social distancing.

Just a reminder the kids should be wearing their masks when they are out and surrounded by others. Last week they face timed me while playing outside at Seans new place with new friends. Not one of them nor Sean were wearing face masks and all standing closer than 3ft with strangers they just met.

Given his concerns expressed to the school principal via email yesterday about returning to in school learning and "potential" exposure of his 63 year old Aunt, I am concerned he would allow the kids and himself to be so careless with mask wearing especially being new there and then go stay with his aunts with the kids yet he's concerned the kids are exposing his aunts by attending school with masks and strict social distancing.

It is within communities that Covid is spreading. Not the schools. The schools are responding to exposure brought in by those not taking precautions in day to day activities in the community.

However the 63 year old aunt Sean specifically referred to in an email to the principal also works in healthcare and knows her risks. If she is still going into work to assist with oral surgeries she is educated and capable of taking appropriate precautions around the children and I hope that he and all of you recognize the contradiction in the words and actions of Sean.

Please keep our children protected and follow social distancing guidelines when they are with you.
