The following is a summary of the events that occurred on Tuesday December 12, 2023.

On Tuesday December 12, 2023 I was on duty in the Town of West Boylston. At approximately 2241 hours, I was dispatched to 36 Temple Street for the report of a verbal domestic.

At approximately 2247 hours Officer St.Martin and I arrived on scene. We were greeted outside by Thomas Cosgrove MA OLN: S47191391. Mr. Cosgrove stated he and his girlfriend Christine Venti MA OLN: S12246185 had a verbal argument. Mr. Cosgrove stated Ms. Venti and her daughter were arguing about a cell phone and he got upset because it was late and he had work in the morning. I asked Mr. Cosgrove if Ms. Venti was physical with him and he stated no. Officer St. Martin spoke with Mr. Cosgrove and I entered the residence to speak with Ms. Venti.

Ms. Venti stated her and her daughter were arguing when Mr. Cosgrove became very upset and started to yell at her and her daughter. I asked Ms. Venti if Mr. Cosgrove got physical with her and she stated no. I asked Ms. Venti if she had anywhere else she could stay for the remainder of the evening and she stated she didnt have anywhere to go. Ms. Venti stated she pays \$1400 a month for rent and the last time they got into an argument she left and went to a hotel, and that she wanted Mr. Cosgrove to stay in his camper until morning. I asked Ms. Venti if she felt safe staying at the residence with her children and she stated yes.

I returned outside and asked Mr. Cosgrove if he had anywhere else he could stay for the night. Mr. Cosgrove stated he would stay at his fathers but he has COVID 19. Mr. Cosgrove stated he just wanted to go to bed and didnt wish to speak or argue with Ms. Venti for the remainder of the evening. I asked Mr. Cosgrove if he was willing to sleep in his camper and he stated he just wanted to sleep in his car where it was warm. I advised Mr. Cosgrove and Ms. Venti to call the Police if there were any more issues, and they both agreed not to argue and stay away from each other for the rest of the night. Shortly after, Officer St.Martin and I cleared the scene.
