"What Is AccreDefi?"

Answer:



AccreDeFi is a comprehensive multi-chain compliance infrastructure for tokenizing real-world assets. We provide the complete toolkit for asset tokenization, identity verification, compliance management, escrow services, and trading—all in one platform.

"How does AccrediRep scoring work?"

Answer:



AccrediRep evaluates token issuers across 10 weighted factors including compliance record, transparency, and security practices. Everyone starts at 600 points with a grace period for your first three transactions. Higher scores earn higher instant cash-back rebates plus lifetime residual income on trading fees.

What is AccrediWallet and how do I get one?

Answer:



AccrediWallet is your HD-generated wallet with built-in compliance and sequential numbering. During registration, we generate your wallet before payment using BIP-39 standards. It's compatible with MetaMask, XDCPay, and other major wallets, with AES-256-GCM encryption protecting your keys.

What is AccrediSoul (SBT)?

Answer:



AccrediSoul is your Soulbound Token—a non-transferable digital identity tied to your wallet. It stores your KYC credentials, TIRN score, and compliance status on a private subnet while publishing only a boolean compliance check to public chains. One wallet, one SBT, forever.

"How does the tokenization process work?"

Answer:



Submit your asset details, complete KYC verification through our KYC 2020 integration, pay the registration fee in ACDF tokens, and we'll mint your compliant token with embedded compliance DNA. Your token is automatically registered in AccrediBook and ready for trading.

"What is XOrdinals?"

Answer:



XOrdinals (XDC Ordinals) is our immutable audit trail system. Every sensitive action—SBT minting, compliance changes, token creation—gets permanently inscribed on-chain as an ordinal.

This creates an unforgeable record for regulators and auditors.

"How does Xscrow work?"

Answer:



Xscrow is our built-in escrow service for secure transactions. When you list an asset on our marketplace, it's held in smart contract escrow until sale conditions are met. Funds are released automatically upon compliance verification, eliminating counterparty risk.

"What is AccreFlo?"

Answer:



AccreFlo is our DEX with ImpermaGain liquidity pools that solve impermanent loss problems for institutional liquidity providers. It enables compliant trading of tokenized assets with integrated KYC checks and automated settlement.

ISO20022 is the global standard for financial messaging used by banks, SWIFT, and major financial institutions. Our integration ensures seamless communication with traditional finance infrastructure including DTCC, R3 Corda, and BIS projects.

"What chains does AccreDeFi support?"

Answer:



We're live on XDC Network with expansion to TON, BNB Chain, Polygon, and Tron. Our bridgeless bridging technology maintains compliance integrity across all chains without creating regulatory gaps.

"What are the fees?"

Answer:



Registration requires a KYC verification fee of \$150 USD payable in ACDF tokens at a discounted rate, plus annual membership. Marketplace transactions incur a 2.5% fee. Your AccrediRep score determines your instant cash-back rebate percentage.

"What is the Analytics Dashboard and Global Marketwatch?"

Answer:



Your dashboard provides real-time analytics on your TIRN/GTRN scores, token performance, trading volumes, and residual income. Global Marketwatch shows live market data across all tokenized assets on the platform with institutional-grade charting and analysis tools.

"How secure is the platform?"

Answer:



We use military-grade AES-256-GCM encryption, HSM for key management in production, multi-sig recovery mechanisms, and comprehensive smart contract audits. All critical actions are logged in XOrdinals for immutable audit trails.

"Who can use AccreDeFi?"

Answer:



Anyone can register, but you must complete KYC 2020 verification and receive an AccrediSoul SBT before tokenizing assets or accessing compliance-gated features. Institutional accounts receive expedited onboarding.

"How do I get started?"

Answer:



Visit our registration page, generate your AccrediWallet, pay the \$150 verification fee in ACDF tokens, complete KYC 2020, and receive your AccrediSoul SBT. You'll start at 600 points with your first three transactions risk-free.
