Thai Elite Visa 🏰

- **Duration:** Up to **5–20 years**.
- **Best for:** Long-term stays, retirees, or high-net-worth individuals.
- **Requirements:** Large upfront fee, with benefits such as VIP services, airport access, and long-term residency.
- **Tax Status:** You will need to pay taxes on income earned within Thailand, but no taxes on foreign income if you're a **non-resident**.

Non-Immigrant B Visa 🧳

- **For:** Entrepreneurs or employees working in Thailand.

Consider Business Structure

If you plan to stay long-term and run a business, consider setting up a **Thai Limited Company**. This can provide a more flexible tax situation by allowing you to:

- Deduct business expenses.
- Pay taxes at **corporate tax rates** instead of personal income tax rates.

Tax Incentives for Entrepreneurs

- If you set up a **business** in Thailand (especially in tech or innovation), you might be eligible for **tax incentives** like **BOI (Board of Investment)** promotions, which offer exemptions on corporate income tax for specific sectors.

Income Tax Rates

- The personal income tax rates in Thailand range from **5% to 35%** based on your income, with **tax brackets** as follows:
 - Up to **฿150,000** – 5%
 - **฿150,001 to 300,000** – 10%
 - **฿300,001 to 500,000** – 15%
 - **฿500,001 to 750,000** – 20%
 - And so on up to **฿5 million+**.
