EXEMPTION / PARTIAL EXEMPTION WITH REGARD TO SCHOOL FEES:

Parents / guardians may apply for an exemption / partial exemption regarding school fees. Parents / Guardians may acquire an application form from the school themselves.

SCHOOL FEES STATEMENTS:

Four statements will be issued for the year – one with each report that is issued to your child / ward.

In terms of the provisions of Section 40 of the South African School's Act, 84 of 1996, parents are obliged to pay School fees.

1. PREAMBLE

- 1.1 School fees are determined in consultation with the parents of this School.
- 1.2 School fees are payable annually in advance by close of business on **31 JANUARY 2027**. However, the school is prepared to accept payment of annual School fees in instalments in accordance with the undertaking contained in paragraph 2.3.2, 2.3.3 and 2.3.4 of this agreement and no indulgence or latitude will be construed as a waiver or novation of any rights the school may have.
- 1.3 The contractual provisions of this agreement are ancillary to and in no way replace the provisions of the South Africans School Act 84 of 1996.
- 1.4 This Agreement to pay school fees will be **valid for the duration of the period that the child / ward is at Heather Secondary School.**

2. UNDERTAKING

- 2.1 I/We, the undersigned, hereby acknowledge liability for the annual School fees and I/we undertake to pay the annual School fees per learner per year according to the amount determined by the Heather Secondary School Governing Body at its Budget Meeting held in October / November on a yearly basis. The school fees are approximately a 10% increase on the previous year's school fees.
- 2.2 I/We further undertake:
 - 2.2.1 To pay the School fees timeously in accordance with the provisions of this agreement;
 - 2.2.2 To give the School at least THIRTY (30) days written notice in the event of the learner(s) leaving the School, and in the event of my/our failure to give notice as provided in this agreement, I/we agree to pay pro rata School fees for a period of THIRTY (30) DAYS after the learner(s) has/have left the School.
- 2.3 I/We undertake, notwithstanding the date of signature of this agreement, to pay School fees:

2.3.2	Two equal payments totalling the school fees for the year - payable by 01/06/2027 and 30/10/2027.	R 1300.00

2.3.4	Ten equal payments totalling the school fees for the year – to be paid monthly from 30/01/2027 to 30/10/2027.	R 260.00

- 2.4 I/We undertake the following:
 - To ensure that my/our child/ward attends school regularly.
 - To take an active and consistent role in supporting my/our child/ward's education, including monitoring academic progress, homework, and assessment requirements.
 - To reinforce the values of respect, discipline, responsibility, and integrity in alignment with the ethos of Heather Secondary School.
 - To maintain open, respectful, and constructive communication with the school, and to attend scheduled meetings, consultations, and school engagements where required.
 - To support the school in upholding high standards of behaviour and accountability, and to work collaboratively with educators when challenges arise.
 - To create a home environment that is conducive to learning, wellbeing, and personal growth.
 - To ensure that my/our child/ward adheres to Heather Secondary School's Code of Conduct as well as the dress code.
 - To contribute to the School Fees in terms of Section 39 & 40 of the South African School's Act (Act 84 of 1996).
 - To pay all costs for damage done or losses caused by my/our child/ward to the school's property, textbooks and equipment.
 - **A deposit of R 3000,00 is payable on date of acceptance of registration.**
- 2.5 I agree that the PRINCIPAL and his designates may act in *loco parentis* in the event of any injury or accident in which my child/ward may be involved.

3. **DEFAULT**

- 3.1 Should I/we fail to make payment in accordance with this agreement and the option selected then the full outstanding balance of the School fees for the year will immediately become due, owing and payable in November 2027.
- 3.2 Should I/we fail to make payments in accordance with this agreement, the School may institute legal action against me/us for collection of the arrear School fees, in which event I/we shall be liable for costs on the scale as between Attorney and client, including collection commission, VAT thereon and tracing costs.
- 3.3 Parents accept that their liability shall be joint and several, the one paying the other to be absolved, for the full amount owing. If the parents are separated or divorced then, by their signature hereto, they acknowledge their joint and several liabilities and confirm that any agreement between them regarding the payment of school fees is not binding upon the school.
- 3.4 I/We nominate either my/our home or my/our work address/s as my/our *domicilium citandi et executandi* for service of legal process. The school may elect at its discretion to serve legal process at either address.
- 3.5 A statement issued by the school shall be *prima facie* proof of any amount outstanding in terms of this agreement.

4. **GENERAL**

- 4.1 This agreement must be signed by both parents/guardians.
- 4.2 No variation or amendment of this agreement will be of any force or effect, unless it is reduced to writing and signed by the parents/guardians and the School.

5. **PERMISSION TO CONDUCT CREDIT SEARCHES**

I/We grant permission to the School's Bursar and/or Secretary or any other duly authorized school employee to make all and any enquiries and to conduct all and any investigations, as deemed necessary, to confirm, verify and update my/our personal details: to ascertain, determine and monitor my/our credit worthiness and in connection with any legal proceedings.

6. **PROVISIONS RELATING TO THE SOUTH AFRICAN SCHOOLS ACT NO. 84 OF 1996 AS AMENDED**

The School wishes to draw your attention to the following:

- 6.1 In terms of Section 39 of the South African Schools Act 84 of 1996 a public school may determine and levy school fees only if a resolution to that effect was adopted by a majority of parents at a budget meeting.
- 6.2 In terms of Section 40 of the South African Schools Act 84 of 1996 parents are liable for payment of school fees unless or to the extent that the parents have been exempted from payment in terms of the aforesaid Act. School fees are a statutory obligation which the learner's parents/guardians must fulfil in terms of the provision of Section 40 (1) of the South African Schools Act 84 of 1996 and parents (married, unmarried or divorced) are jointly and severally liable.
- 6.3 Heather Secondary School is a Public School and has not been declared as a "*no fees school*". The definition of a Public School is contained in Chapter 1 and the provisions relating to Public Schools are contained in Chapter 3 of the South African's Schools Act.
- 6.4 The school fees for 2027 will be in accordance with a Resolution adopted by most parents at a general meeting which will determine the school fees for the 2027 academic year per learner per year. The criteria used by the school for the granting of exemptions / partial exemptions, regarding school fees, to parents / guardians is in accordance with those published under Government Notice R1052 published in Government Gazette R29311 of the 18 October 2006.
- 6.5 A copy of these Regulations are displayed in the foyer of the main entrance to Heather Secondary School or may be obtained on request from the Bursar.
- 6.6 In terms of Regulation 3 of Government Notice R1052, parents/guardians are liable for the payment of School fees unless he/she or they have been granted an exemption / partial exemption regarding the payment thereof.
- 6.7 I/We hereby confirm in terms of S41(4)(c) read with Regulation 3(1)(c) of Government Notice R1052 (which deals with the exemption of parents from the payment of school fees) as follows:
