**Medical Inactive Policy for the
Cutchogue Fire District
Town of Southold
County of Suffolk
State of New York**

POLICY

The Cutchogue Fire District is establishing a policy for the transfer of active and probationary volunteer firefighter members of Cutchogue Fire Department, United Fire Company No. 1 to the Medical Inactive List by the Chief of the Cutchogue Fire Department.

CRITERIA FOR PLACEMENT ON THE MEDICAL INACTIVE LIST

Any active or probationary member, who for any reason is unable to perform his or her duties, as a volunteer fireman due to a physical or mental situation, shall inform the Cutchogue Chief's Office. A Cutchogue Fire Chief shall: (a) inform the member and have the member sign a copy of this Medical Inactive Policy to be placed in his/her file; and (b) notify, in writing, the Fire District Secretary that the active or probationary member is being placed on the Medical Inactive List.

Any active or probationary member who is transported to a hospital as a patient, in an ambulance, shall automatically be placed on the Medical Inactive List, until cleared by the District medical provider.

If the member is placed on the Medical Inactive List, it is the member's responsibility to see their personal physician for clearance to return to duty, clearance will be forwarded to District medical provider to ascertain when the member can be removed from the Medical Inactive List.

WHILE ON THE MEDICAL INACTIVE LIST

1. Upon the member's receipt of the Fire Chief's notification that the member is being placed on the Medical Inactive List, the member shall immediately cease in the performance of any volunteer firefighter duties or functions including, but not limited to: reporting to any fire/rescue alarms, participating in company training, driving district vehicles, attending any company meetings, events, fundraisers, sporting events or any company or department activities.

2. Any member while on the Medical Inactive List is permitted to visit the firehouse, the firehouse grounds or the Cutchogue Fire Department Annex at public functions and by doing so acknowledges the member is visiting in the status as a private citizen and not as an active or probationary firefighter of the Cutchogue Fire Department, United Fire Company No. 1. Members on medical inactive covered by workman's compensation may attend feeds or meetings after signing a waiver.

3. Any member on the Medical Inactive List for more than six (6) months shall have their condition re-evaluated by their treating physician and approved by the Fire District physician to continue current status.

4. The Fire District sponsors a Length of Service Award Program (LOSAP), and has adopted a LOSAP Point System. Under the Point System, active members can earn points for attending certain activities as outlined in the Point System document. Since LOSAP points can only be earned for attending activities as an active volunteer firefighter, a member on the Medical Inactive List will not have the opportunity to earn points while on the Medical Inactive List. However, if the member suffered a line-of-duty injury, the member may be eligible to receive points during the period the member is injured and on the Medical Inactive List pursuant to the LOSAP Point System. 5 points for each complete month that the member is deemed to have a "total and temporary" or a "partial and permanent" disability as certified by Workers' Comp Board.

6. If the member is a probationary member when placed on the Medical Inactive List, he/she shall continue his/her probationary period will be extended by the amount of time member was on medical when resuming active member status.

7. If any active member is placed on the Medical Inactive List and has remained for a continuous one (1) year period of time from placement and is unable to return as an active volunteer firefighter then said member shall be required to make an application to become an Inactive Member, or Honorary or Veteran firefighter. In the alternative, the active member may submit his/her resignation from the United Fire Company No. 1 of the Cutchogue Fire Department.

8. In the event that an active member is placed on the Medical Inactive List and fails to comply with the requirements of this policy, the member may be dropped from the rolls. Further, in the event that an active member is placed on the Medical Inactive List and remains for a continuous one (1) year period of time from placement and is unable to return as an active volunteer firefighter, and such member does not avail him/her self of the options set forth in paragraph "7" above, then the member shall be dropped from the rolls.

CRITERIA FOR REMOVAL FROM THE MEDICAL INACTIVE LIST

The Fire Chief shall remove a member from the Medical Inactive List only when the Fire Chief is in receipt of written notification from the Fire District physician indicating that the firefighter is cleared to resume duties as a volunteer firefighter. Upon removal of the member's name from the Medical Inactive List, a Cutchogue Fire Chief shall notify the Fire District Secretary, in writing.

LINE OF DUTIES INJURIES

If a member has been injured either going to an alarm, during the alarm, or returning from an alarm, the member must notify the Officer in Charge to complete the proper injury forms to be sent to the insurance carrier and Fire District Secretary. Volunteer Firefighter Benefits Law (VFBL) guidelines shall be followed.

NOTIFICATION

Any member who has been injured or disabled for any reason or at their personal employment who is subject to the rules of Workers Compensation Board shall inform the Cutchogue Fire Chief's Office as soon as possible of their condition for possible placement on the Department's Medical Inactive List.

Any member who shall fail to promptly notify the Cutchogue Fire Chiefs Office of injuries or illness for any reason shall be subject to disciplinary action.
