POSTING OF 2024 SERVICE AWARD PROGRAM POINTS

Any firefighter who is noted as having earned fifty (50) or more points during 2024 will qualify for service credit, provided the minimum age requirement and/or other participation requirements as stipulated in the Plan Document are met.

If you are listed as <u>not</u> earning at least fifty (50) points, but your records indicate that you attended enough activities to earn at least fifty (50) points during 2024, you have the right to appeal within thirty (30) days of the date on which the list was originally posted.

If you wish to submit an appeal, in accordance with the New York State General Municipal Law Section 217(g), the appeal must be in writing and mailed to the Fire District Secretary. You should formally file this appeal to ensure it is officially recorded. However, we also ask that you contact the Fire Department representative noted below, who will perform an initial review of your appeal and work with the Board of Fire Commissioners to make any adjustment that may be required.
