Summary of Position:

- A Public Works Laborer is responsible for the operation of a variety of construction and maintenance equipment and for performing manual labor activities as needed and/or required by the Public Works Department. The most common type of work performed in this position class also work on roads, park maintenance, sign crews, sewage crews, and in other related areas. The position requires operation of vehicles, such as pick-up trucks, backhoe, street sweeper, dump trucks, salt spreaders, snowplows, etc. as required. The operation of power tools and equipment, such as mowers, chain saws, air compressor, etc. when required is also necessary. The applicant will mow grass, prune trees and hedges, and plant flowers and trees as required. There is a requirement to clean borough offices, garage areas and park facilities, as well as clean up litter and empty trash cans. Maintenance of sanitary and storm sewers and making repairs and/or conducting routine maintenance procedures is required. Sweeping and cleanup of debris and materials from the roads will be required as well as snow and ice removal, including manual shoveling of snow.
- The Water Treatment Plant / Line Maintenance plays a vital role in ensuring safe, reliable
 drinking water and maintaining the integrity of the community's water distribution system. This
 position involves operating treatment plant equipment, performing routine system inspections,
 and conducting maintenance and repair of water lines, valves, hydrants, and related
 infrastructure.

Principle Responsibilities:

- Assists in the cleaning and unclogging of storm sewer lines, manholes and catch basins; assists other personnel in such tasks as laying storm sewer lines and building manholes and catch basins; assists other employees in miscellaneous concrete work.
- Performs various street maintenance duties such as cleaning gutters, spreading salt and shoveling snow; picks up fallen tree limbs and branches; assists in the installing and cleaning of culverts.
- Monitor, operate, and adjust plant equipment and control systems.
- Collect and analyze water samples; record operational data.
- Perform daily inspections to ensure compliance with regulatory standards.
- Assist with chemical handling, feed systems, and routine plant housekeeping.
- Install, repair, and maintain water mains, service lines, valves, meters, and hydrants.
- Locate underground utilities and respond to service calls, leaks, and line breaks.
- Perform flushing, pressure testing, and routine system maintenance.
- Operate construction and maintenance equipment such as backhoes and compactors.
- Loads and unloads heavy materials from trucks; moves or aids in moving heavy boxes or equipment; operates aggregate spreader box in asphaltic-concrete paving work.
- Engages in a variety of grounds maintenance work such as cultivating, pruning, spraying and trimming, cuts grass and weeds with hand tools and power mowers.
- Performs routine maintenance work such as filling equipment with gas, checking oil, sharpening mower blades and other related work.
- Assists in the maintenance and repair of buildings and equipment; inspects equipment for safety and makes repairs as needed.
- Performs routine maintenance on new and existing traffic control devices such as installing, repairing and replacing traffic signs and signposts.
- Operates hand striping machine to install crosswalks and parking stall lines; uses hand paint guns to paint curbs and lines; sets cones on ground to protect work areas; installs plastic pavement markings.
- Is on call and assures there is always coverage in case of emergencies
