Information We Collect

Personal Data When engaging with our services, we may collect:

- Full name and contact details
- Email address
- Company name and professional background
- Payment and billing information (processed securely via third-party providers)
- Any information voluntarily submitted through enquiry or consultation forms

Usage Data We automatically collect technical data including IP addresses, browser type and version, pages visited, time and duration of visits, and device identifiers.

Tracking Technologies & Cookies

We use cookies and similar technologies to enhance your experience on our website. These include:

- **Essential Cookies** — necessary for core website functionality



- **Functionality Cookies** — to remember your preferences and personalise your experience
- **Analytics Cookies** — to understand how visitors interact with our site and improve our services

You may instruct your browser to refuse cookies at any time, though this may affect certain features of the website.

How We Use Your Information
