Austin Imaging and Lab (“we,” “our,” or “us”) values your privacy and is committed to protecting your personal information. This Privacy Policy explains how we collect, use, and share information when you visit our website, communicate with us, or use our services, including SMS messaging and AI-assisted communications.

1. Information We Collect

We may collect the following types of personal information:

- **Personal Information:** Name, phone number, email address, mailing address, and date of birth

AI tools do not make medical decisions and do not replace licensed healthcare professionals.

4. How Personal Information Is Shared

We do **not** sell or rent your personal information.

We may share personal information only with:

- Healthcare providers involved in your care
- Service providers that support our operations (such as phone, SMS, scheduling, or communication platforms like RingCentral)
- Legal or regulatory authorities when required by law

All service providers are required to protect your information and use it only for authorized purposes.

5. SMS/Text Messaging Consent

If you consent to receive SMS/text messages from Austin Imaging and Lab:

- Messages may include appointment reminders, scheduling updates, and service-related notifications
- Message and data rates may apply
- You may opt out at any time by replying **STOP**

SMS consent is not shared with third parties or affiliates.
