### Storm Hits Lincoln County, Destroys Homes

On May 14, a tornado swept through Lincoln County, damaging more than 30 homes and knocking out power for thousands. Winds reached up to 120 miles per hour, and multiple trees were uprooted. Emergency crews arrived quickly, and no serious injuries were reported. Meteorologists say the storm developed from a fast-moving cold front that collided with warm air in the region. The tornado lasted about 12 minutes before moving out of the area.

#### Introducing the Text

### **Before Reading Discussion Questions**

- 1. What's the difference between writing about something you lived through and writing about something you read or heard about?
- 2. Have you ever kept a journal or read a news story?
- 3. What kind of details would you expect in a news report?

### **During Reading Discussion Questions**

- 1. How does Ellie describe what happened during the tornado?
- 2. What facts does the newspaper include that Ellie doesn't mention?
- 3. How do the feelings in the journal entry compare to the facts in the article?

### **After Reading Discussion Questions**

- 1. Which text gives you a stronger emotional picture of the event?
- 2. How do the two texts work together to help you understand the tornado better?
- 3. Why is it important to read both firsthand and secondhand accounts?

### Activity Idea

Have students create a two-column chart labeled "Firsthand" and "Secondhand." Ask them to sort phrases from both texts into the correct column. Then they write a short paragraph explaining one key difference between the two perspectives, using evidence from both.
