Every day, people in the United States use over 500 million plastic straws. Many of those straws end up in oceans, rivers, and landfills. Some people believe plastic straws should be banned to help protect the environment. Others argue that banning straws could cause problems for people who rely on them.

One reason to ban plastic straws is that they harm sea life. Straws often end up in the ocean, where turtles, fish, and seabirds can mistake them for food. According to the Ocean Conservancy, plastic has been found in 100% of sea turtles studied. By banning straws, we can help reduce the amount of plastic that enters oceans and harms animals.

Another reason is that plastic straws never fully break down. They can last for hundreds of years, creating more and more waste over time. Replacing plastic straws with paper, metal, or reusable options could cut down on pollution.

However, not everyone agrees with a full ban. Some people with disabilities need plastic straws to drink safely. Unlike metal or paper straws, plastic ones can bend, don't get soggy, and don't cause injury. For these individuals, plastic straws are not just convenient—they are necessary.

Instead of banning straws completely, some cities have passed laws that limit straw use but still allow them when needed. These rules try to balance protecting the environment with helping people who need plastic straws.

So—should plastic straws be banned? It depends on how we balance caring for the planet with caring for one another.
