

# BCKK Green Future Committee



## Purpose & Scope

BCKK Green Future Committee monitors environmental and sustainability policies — including circular economy, waste management, resource efficiency, and EU-aligned green standards, — and assesses their impact on BCKK members. This is in line with the Declaration of the Western Balkans Sofia Summit, held on 10 November 2020, where the Region reached an important milestone by endorsing the Leaders' Declaration on the Green Agenda that aligns with the EU Green Deal. It serves as a hub for insights, advocacy, and collaboration with government bodies, NGOs, and experts.

## Our Aim

To support business transition to sustainable and circular practices, reduce environmental risk, and drive Kosovo's green economy — by empowering members through knowledge-sharing, policy engagement, and industry cooperation.



## Key Services & Activities

### 1. Policy & Circular Regulation Monitoring

- Track environmental legislation, EU-aligned standards, Kosovo's **Circular Economy Roadmap**, and sustainability initiatives (e.g., waste management, renewable energy, water protection).
- Prepare member-friendly summaries with actionable insights. Issue concise briefs and actionable insights on emerging circular regulations, green energy and waste strategies.

### 2. Member Briefings & Alerts

- Send policy flash alerts on circular economy topics: extended producer responsibility (e.g., EPR schemes, emissions targets), waste grants, green procurement, and recycling mandates.
- Promote green trends, meeting national EPR targets, green energy, nature protecting and funding windows.

### 3. Webinars & Workshops

- Host learning sessions on topics like carbon reduction, circular economy, green energy, and ESG strategies.
- Organize panel discussions featuring environmental experts, regulators, and sustainable business leaders.

### 4. Site Visits & Eco-Showcases

- Organize visits to renewable energy leading green energy facilities, recycling plants, or sustainable farms and recycling facilities.
- Feature green business showcases to highlight circular best practices.

### 5. Advocacy & Public Consultation

- Draft responses on renewable energy, circular-economy and environmental regulations, EPR schemes, green public procurement, and waste policies.
- Engage policymakers to include business perspectives in circular framework development.

## 6. Green Networking & Collaboration

- Connect members with environmental NGOs, green finance providers, research institutions, and UK technical assistance.
- Support partnerships to innovate in recycler-manufacturer loops, biomaterials, and shared services.

## 7. Member Support Services

- Offer guidance on EPR compliance, circular certification, environmental audits, and sustainability reporting.
- Provide referrals to consultants specializing in recycling, waste-to-energy, eco-innovation, or green design.

## 8. Member Engagement

- Distribute post-meeting summaries highlighting policy progress, upcoming grants, and member opportunities.
- Outline achievements, impact, and next steps.
- Solicit feedback through surveys and roundtables to align future work with member needs.
