Mentors junior staff, paramedics and student nurses in End of Life, Tissue Viability, medicine management and comorbidities. As a clinical lead in classification of wounds and pressure ulcers I have also taken on the role of teaching this for clinical updates of staff.

Is able to combine work in palliative care with District Nursing, thus maintaining competency in this field, including regularly updating tissue viability competencies – an area of specialism whilst studying for BSc.
