Her work has involved setting up pre-assessment clinics, colonoscopy lists, policies, procedures, patient group directives, and compiling annual reports. She also holds managerial responsibility for a team of 10 nurses.

In addition to her primary role, she has spent the 9 years serving as a Regional Professional and Clinical Advisor for the Quality Assurance (QA) team within Public Health England. As part of this role, she conducts QA visits to other screening centres across the West Midlands, providing recommendations and support to ensure compliance with national screening standards. She also contributes to regional and national bowel cancer screening study days, further enhancing her professional development within the field.
