General Background

A registered adult nurse since 1997 with experience working in a variety of healthcare settings- hospital, hospice and community. Specialised in palliative and end of life care since 2001. Previous role was Head of In-Patient services at a hospice holding full responsibility for the 33 beds. Has extensive knowledge and experience in assessing, planning, implementation and evaluation of patient care. Management responsibilities included clinical governance, staff training and competencies, absence management, health and safety, infection prevention, audits and medicines management.

Most recent role is community hub and hospice at home team leader working in a community setting. The role includes a 24/7 advice line, responsibility for all hospice patients within nursing and care homes, rapid response visits 24/7 and providing support to patients in their own homes with end-of-life care. Also, a non-medical prescriber since 2005 supporting patients with symptom management.

Prior to the hospice Clare was in the Royal Air Force carrying out various roles in a military hospital as corporal/senior staff nurse. Worked in various areas- colorectal surgery, infection ward/isolation, male medical, female medical, outpatients and A+E. As well as her nursing role she completed military roles and duties- guard duty, training courses, and casevac duties- bringing injured patients back to Britain from deployment.
