## **General Background**

A registered nurse who qualified in 1994, Colette has a clinical background in District Nursing, Chronic Disease Management, Tissue Viability, and is also a non-medical prescriber. Her practice has primarily taken place within Community healthcare settings, including patients' homes, nursing homes, community hospitals, GP practices, university settings, and mental health services. Up until the end of January 2026, Colette held a national clinical and quality assurance role with NHS Supply Chain, focusing on the safety and performance of medical devices and healthcare products, including those for wound assessment prevention and management. She led, developed and implemented processes to embed Human Factors principles within the organisation's quality assurance, with an emphasis on patient safety and service improvement. Colette is currently continuing to develop her Expert Witness role with AMG Medico Legal Limited and will be undertaking the Bond Solon Expert Witness Training in May 2026.
