#### **General Background**

Miranda Hodgkin is a Registered Children's Nurse/Non-Medical Prescriber and is a NMC Clinical Assessor. Miranda has been qualified in paediatric nursing since 1998 and has an extensive knowledge of paediatrics and paediatric oncology, undertaking a variety of roles progressing from a Junior Staff Nurse, Project Manager and for a substantial time as a Clinical Nurse Specialist. Her paediatric oncology career experiences include haematology cancers, Brain tumours and management of shared care for oncology patients regionally. She has liaised with various multi-disciplinary teams within Paediatric Oncology across the Yorkshire region to assist with the delivery of a safe and effective service. She has played a key role in its development with the provision of teaching packages, setting up the foundation training, and the teaching and assessing the Link nurses to lead the service. Miranda has worked independently to run nurse led clinics prescribing and monitoring oral chemotherapy. She has experience in day case and triage/acute assessment within paediatric oncology.

Miranda has recently worked closely with Public Health England to collect essential data on behalf of the trust to investigate an outbreak of pseudomonas within the Haematology Unit.

Miranda recently worked for the Nursing Midwifery Council as a clinical assessor. Through formal examinations of objective structured clinical assessments, non-registered staff are assessed against the standards of the NMC and the Royal Marsden Guidelines (Test of competence) to gain entry onto the Nursing Register. The primary purpose of the assessor role is to support and examine registered and unregistered staff in their clinical practice and observe competence as set by the regulatory bodies, to meet the standards required to deliver high-quality evidence-based care for service users.

Miranda currently works as a clinical nurse specialist in the Childrens epilepsy service providing specialist support to children who have a diagnosis of epilepsy or who are suspected to have epilepsy and their families. The support is provided in a variety of settings including patients' homes, schools, nurseries hospital clinics or over the telephone. The role works closely with partnership services in health, education, social care and the voluntary sector providing education packages for staff within those areas.
