1) Apologies for absence

2) Minutes from the previous meeting held on Thursday 11th June 2025

As per EN Guidelines, ideally the main coach should not be the Club Safeguarding Officer.

A reminder that when asking for cover ensure the umpiring capability is appropriate. Following guidance from Lincolnshire County Kirsty will be looking at Fixture to try and put an experienced umpire with a less confident umpire to try and balance and improve confidence.
