### 1. Purpose of this Privacy Notice

Emergency Aid of Boulder City, Inc. (“EABC,” “we,” “our,” or “us”) respects your privacy. This Privacy Notice explains how we collect, use, store, and share personal information provided by clients, volunteers, donors, community partners, and other individuals who interact with us.

### 2. Information We Collect

We may collect the following types of personal information:

- **Contact information** such as name, mailing address, email, and phone number.
  - **Demographic information** you choose to share, such as city/state, age group, or role (e.g., volunteer, client).
  - **Media content** such as photographs, video, or audio recordings, with your consent.
  - **Donation information** such as amounts, frequency, and any dedication notes, but not full payment card details.
  - **Service use details** such as program participation or volunteer activities.

### 3. How We Use Your Information

We use personal information to:

- Provide and improve our charitable services.
  - Communicate about events, programs, and opportunities.
  - Recognize contributions and community partnerships (with consent).
  - Meet legal, tax, and reporting obligations.
  - Maintain internal records for accountability and safety.
- 

### 4. Legal Basis for Processing

We process personal information:

- With your consent.

- As necessary to fulfill agreements with you.
  - As required by law or regulation.
  - For our legitimate interests in operating a charitable nonprofit.

## 5. How We Share Information

We do **not** sell personal information. We may share information with:

- Service providers or contractors who assist in our operations (e.g., mailing services, event vendors).
  - Media partners, only with your consent for public use.
  - Government agencies or legal authorities when required by law.
  - Other nonprofits or community partners only when directly relevant to providing you with services and only with your consent.

## 6. Data Security

We take reasonable measures to protect your information from unauthorized access, loss, misuse, or disclosure. However, no system is 100% secure.

## 7. Data Retention

We keep personal information only as long as necessary for the purposes outlined above, or as required by law.

## 8. Your Rights

You may:

- Request a copy of the personal information we hold about you.
- Request corrections to your information.
- Withdraw consent for certain uses (such as public media use) at any time.
- Request deletion of your information, subject to legal and recordkeeping requirements.

For individuals under 18, we require a parent or guardian's consent before collecting personal information, including photos or videos.
