September 01, 2022. The management has represented to me that the certificate has been cancelled without any prior intimation and without providing any reasonable opportunity of being heard. The management was not aware regarding the cancellation. They came to know on 17/10/2022 from the list uploaded on RBIs website. And thence being aggrieved by the cancellation of Registration Certificate; the Company is in process of filing an appeal before the Department of Financial Services, Ministry of Finance, being an appellate authority on NBFC's.</li> </ol>
