#2B3A64 OR “MIDNIGHT BLUE” SHOULD BE USED IN THE CASE OF SOME GRAPHIC
ELEMENTS, LOGOS, OR TEXT. #2B3A64 SHOULD NEVER BE USED IN THE CONTEXT
OF A BACKGROUND APART FROM PERTICULAR CERCUMSTANCES WITH LIGHTER
TEXT AND NOT BE THE MAIN FOCUS OF MOST GRAPHIC DESIGNS



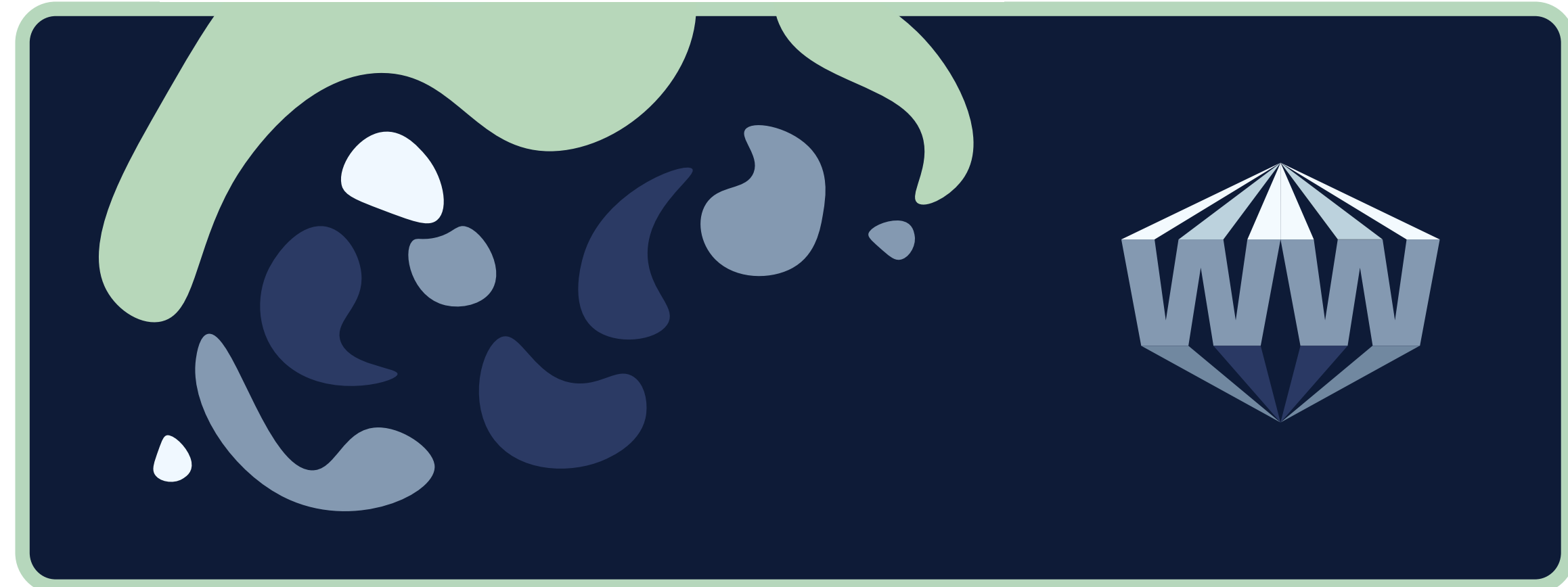

#0E1B37 OR “NOCTURN” SHOULD BE USED IN THE CASE OF FEW GRAPHIC ELEMENTS, OR BACKGROUND ELEMENTS. #0E1B37 SHOULD NEVER BE USED IN THE CONTEXT OF A MAIN BACKGROUND OR MAIN GRAPHIC ELEMENT.

“FUTURA PT” SHOULD ONLY BE USED AS A HEADING OR MAIN POINT. FUTURA PT SHOULD VERY RARELY BE USED AS A PARAGRAPH OR LONG FORM OF TEXT.

“BARLOW” SHOULD ONLY BE USED AS A LONG FORM OF TEXT. IT’S BOLD VARIANTS MAY BE USED FOR HIGHLIGHTING CERTAIN POINTS OR IDEAS. “BARLOW” SHOULD NEVER BE USED AS A HEADER OR MAIN FOCUS OF A PAGE OR SCENE .

MAIN LOGO & FAVICON

SHOWCASES THE DIFFERENT LOGOS AND FAVICON

“BLACK AND WHITE” MAIN LOGO SHOULD BE USED FOR LETTERHEADS, SIMPLE T-SHIRTS OR ANY BLACK AND WHITE ENVIROMENTS. THIS VERSION IS NOT PERMITTED TO BE USED IN ANY MAJOR OR OTHERWISE COLORFUL ADVERTISEMENTS.

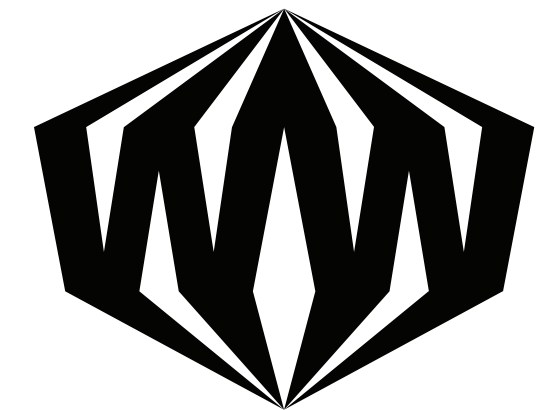


“FULL COLOR” MAIN LOGO IS PERMITTED TO BE USED ANYWHERE UNLESS THE ENVIREMENT COMPLETELY LACKS COLOR.



“DARK” MAIN LOGO IS PERMITTED TO BE USED IN DARKER ENVIROMENTS. IT IS NOT PERMITTED TO BE USED IN ENVIROMENTS WHERE COLOR IS THE FOCUS

FAVICON

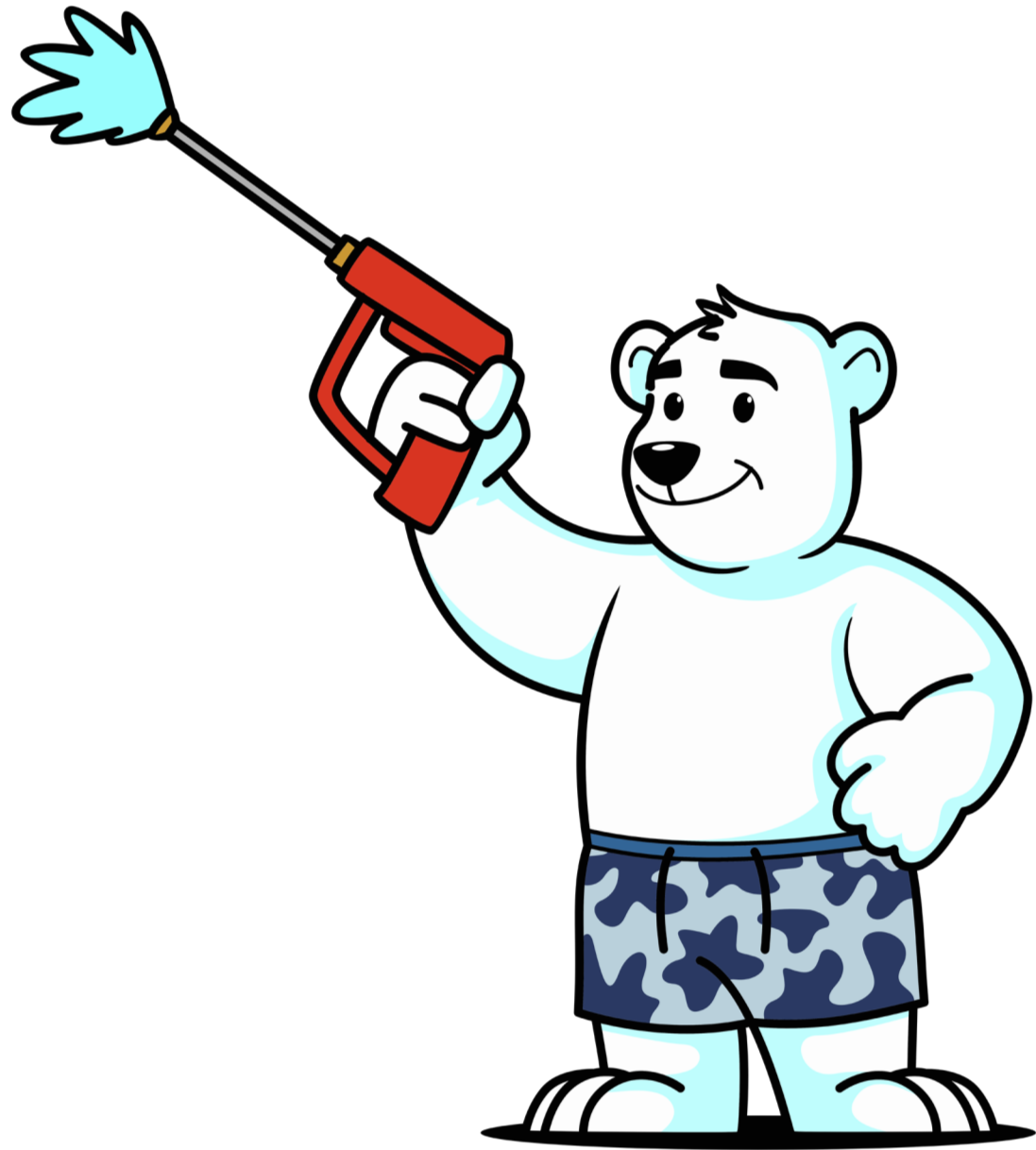


WASHING WARRIORS FAVICON SHALL BE USED AS A FAVACON OR AS A SMALLER SIDE BRANDING ELEMENT. RULES FOR “FULL COLOR” BLACK AND WHITE” AND “DARK” APPLY TO THEIR CORRESPONDING FAVICONS

MASCOT

SHOWCASES THE DIFFERENT LOGOS AND FAVICON
AND HOW THEY SHOULD OR SHOULD NOT BE USED

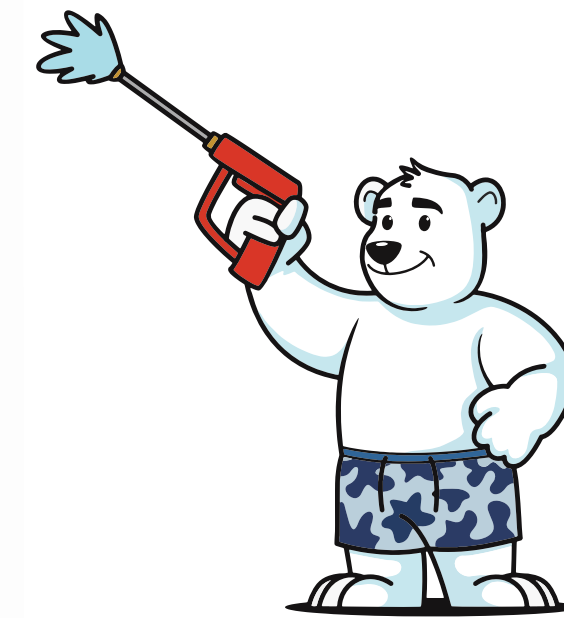
THE “POLAR BEAR MASCOT” SHOULD BE USED AS A SECOND LOGO. IT SHOULD APPEAR ON MOST EVERYTHING, IT IS A KEY BRAND ELEMENT.



MASCOT PNG SHOULD BE USED FOR PROMOTIONAL MATERIAL OR OTHER PLACES WHERE BRAND RECOGNITION IS MOST IMPORTANT. MASCOT PNG SHOULD NOT BE USED IN T-SHIRT OR “FREE FLOATING” DESIGNS.



MASCOT CUTOUT SHOULD BE USED AS A SECOND LOGO. ANYWHERE THE “FULL COLOR” FAVICON IS PERMITTED, MASCOT CUTOUT IS ALSO PERMITTED.



MASCOT WORD LOGO SHOULD BE USED AS AN EXTENSION OF THE VARIATIONS OF THE MAIN LOGOS. THIS CAN BE USED ANYWHERE THE “FULL COLOR” LOGO CAN BE USED.
