Villa Patriz Retreat ("we," "our," "The Villa," "the facility," or "us") is a personally-hosted vacation and events rental, firmly committed to protect your privacy and ensure that we handle your personal information in strict adherence to the Data Privacy Act of 2012 of the Republic of the Philippines (Republic Act No. 10173). By using our website or services, you agree to the terms of this Privacy Policy.

1. Information We Collect

1.1 Personal Information

When you make a reservation, subscribe to our newsletter, or contact us, we collect the personal information you voluntarily provide us. This information may include your name, email address, phone number, booking and payment Information, credit card details, and any identifying data for verification purposes.

1.2 Sensitive Personal Information

2. Use of Information

2.1 Personal Information

We use your personal information to:

2.2 Sensitive Personal Information and Health Data

2.3 Non-Personal Information

Non-personal information is used to:

2.4 Additional Personal Data Handling

 We will keep your shared personal data confidential. Other than the personal data you voluntarily provide, which we use to complete your reservation, we will not collect any other personal details from you. Your personal data will only be accessed and processed by authorized staff of the facility and/or its affiliates and will not be shared, distributed, or disclosed to any other third party.

- We will use your personal data only for the purpose of processing your transactions, creating customer file, and to assist us in addressing inquiries and concerns. You have the right to opt-out or request to be deleted. However, please note that we will not be able to proceed with your transaction once you choose to opt-out.
- Secure procedures will be followed to store and dispose of your data when no longer needed.
- 3. Sharing of Information

We do not sell, trade, or otherwise transfer your personal information to outside parties except as described below:

- Service Providers: We may share your information with trusted third-party service providers who assist us in operating our website, conducting our business, or providing services to you, provided they agree to keep your information confidential and comply with the Data Privacy Act of 2012.
- Legal Compliance: We may disclose your information when required by law or in response to legal processes, such as court orders or subpoenas.
- Protection of Rights: We may disclose your information to enforce our site policies, protect our or others' rights, property, or safety.

4. Data Security

We implement a variety of security measures to protect your personal information in compliance with the Data Privacy Act of 2012. These measures include:
